Liability Release

As the parent or legal guardian of child or youth ("child") named above, I understand that Belle Aire Baptist Church does not require my child to participate in this activity, but I want my child to do so, despite the possible dangers and risks. I give permission to the doctor or health care professional to provide any and all medical care they deem, in their professional opinion, to be necessary.

I agree to pay for any and all medical expenses incurred as a result of the use of this consent.
