## HERE ARE A FEW SIMPLE STEPS YOU CAN TAKE TO GET STARTED...

### **1 CREATE YOUR PARENT PORTAL ACCOUNT AT ACSTO.ORG**

On ACSTO's Parent Portal, you'll be able to review your scholarship applications, update your family information, keep track of your previous award history, and be notified about our Selection Committees' award decisions.

### **2 ADD YOUR STUDENT(S) AND APPLY FOR SCHOLARSHIPS**

Once you've signed up for your Parent Portal account, add your students to your account and then Apply for scholarships. *This is the most important step—we won't be able to award any scholarships for your students unless we have an application for them!*

### **3 GET SCHOLARSHIP RECOMMENDATIONS**

One of the three things that our Selection Committees consider when they make awards is Donor Recommendations. When a donor makes a donation to ACSTO and recommends your student, our committees will consider that when they make their award decisions.

### **4 ATTEND AN ACSTO PARENT WORKSHOP**

Now that your students are eligible to be considered for scholarships, it's time to learn how to increase their chances of receiving one! Our Parent Workshops teach parents the best ways to take advantage of tax credit scholarships. Utilize ACSTO to offset the cost of tuition—ask your school when their next workshop is scheduled!
