- His/her insurance company has primary coverage while students are being transported in his/her vehicle.
- He/she has personal liability coverage of at least \$100,000 per occupant and \$300,000 per incident.
- His/her insurance policy includes under/uninsured motorist coverage.
- All occupants will be required to wear seatbelts and that he/she will transport only as many occupants as there are seatbelts in his/her vehicle.
