¹ Fees for contingencies are negotiated as part of the Carrier Agreement. Potential charges include: Carrier’s estimated bedrest cap for lost wages, childcare, and/or housekeeping (\$5,400) and housekeeping for last month of pregnancy (\$400). Additionally, Carriers would receive fees for the following: C-section (\$2,500), amniocentesis, CVS, D&C or cerclage (\$500 per procedure), termination or selective reduction procedure (\$1,000), mock cycle (\$250), cancelled cycle (\$500), and loss of reproductive organ (\$3,000).
