## RESOLUTION NO, 594 CMS

## A RESOLUTION DECLARING INTENT TO APPROPRIATE PROPERTY FOR SIDEWALK PURPOSES AND DECLARING SAME AN EMERGENCY

WHEREAS, there has developed heavy pedestrian traffic on North Park Streat, in the City of Oberlin, Ohio, and

WHEREAS, it is necessary and advisable for the public peace, health and safety to provide sidewalks for said pedestrian traffic, and

WHEREAS, the existing right-of-way of North Park Street in the City of Oberlin, Ohio is insufficient for vehicular traffic and pedestrian traffic

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Oberlin, Lorain County, Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That it is determined necessary and it is hereby declared to be the intent of this Council to appropriate for public use and public welfare, the perpetual right-of-way, easement and rights here inafter described in, over and across that portion of the real estate now or formerly owned by Bernard Farkas for the purpose of improving, constructing and reconstructing a sidewalk, such perpetual right-of-way and easement being described and set forth as follows:

"Situated in the City of Oberlin, Township of Russia, County of Lorain and State of Ohio, and being part of Original Lot 76 in said Township, bounded and described as follows:

Beginning at a point in the Easterly line of North Park Street distant 429 feat Northerly from the Northerly line of Lorain Street; thence Northerly in the Easterly line of North Park Street 537.9 feet to lands conveyed by the Grantor herein to Oberlin City Board of Education, thence Easterly in said Oberlin Board of Education lands, a distance of 10.0 feet; thence Southerly parallel to North Park Street, 537.9 feet to a point 429 feat Northerly from the Northerly line of Lorain Street; thence Westerly parallel to Lorain Street, 10.0 feet to the place of beginning of lands herein described. Containing within said bounds 0.1234 Acres of lands.

and including a perpetual right of way, easement and right to enter upon said premises at all times to construct a sidewalk, to repair, maintern and improve and remove, and to do any and all things that may be necessary in the judgement of the City of Oberlin, Ohio, in order to construct and repair said sidewalk.

SECTION 2. That the City Manager be and he is hereby authorized to serve written notice of the passage of this Resolution to be given to the owners, persons in possession or having an interest of record in the above described premises and said Notice to be served according to law by a person to be designated for that purpose by said City Manager, or to

serve said Notice by Certified Mail, return receiptrequested.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, safety and welfare of the citizens of the City of Oberlin, Ohio, to-wits

To provide for pedestrian traffic on North Park Street in the City of Oberlin, Ohio, and shall take effect immediately upon passage.
