A RESOLUTION APPROVING CHANGES TO THE BYLAWS OF THE LORAIN COUNTY REGIONAL PLANNING COMMISSION RAISING THE PER CAPITA MEMBERSHIP COSTS FOR MUNICIPALITIES FROM TEN CENTS (.10) TO EIGHTEEN CENTS (.18):

WHEREAS, the City/Village of ~~XXXXX~~ Oberlin is currently a member of the (Lorain County) Regional Planning Commission; and

WHEREAS, the basic cost of maintaining the Regional Planning Commission is shared between member municipalities and the Board of County Commissioners in accordance with Section VII of the Bylaws of the Commission; and

WHEREAS, paragraph 1, Section VII of these Bylaws states:

"1. Each municipality cooperating herein shall contribute in each calendar year ten (10) cents per capita of its population, according to the latest Federal Census or such governmental census as may be agreed upon between the Executive Committee of the Regional Planning Commission and the municipality, but not less than \$100.00 in each calendar year. Such contribution shall be paid in January of each year." and

WHEREAS, the Council/~~XXXXXX~~ Planning Commission of the City/~~XXXXX~~ Village of Oberlin has been notified in writing that at its June 10th meeting, the

Regional Planning Commission approved the following amendment to Section VII - Financial Provisions, A - Apportionment of Costs, of its Bylaws:

The deletion of the words "ten (10)" in the second sentence of paragraph one and the substitution in place thereof of the words "eighteen (18)", so that the paragraph would read:

"1. Each municipality cooperating herein shall contribute in each calendar year eighteen (18) cents per capita of its population according to the latest Federal Census or such governmental census as may be agreed upon between the Executive Committee of the Regional Planning Commission and the municipality, but not less than \$100.00 in each calendar year. Such contribution shall be paid in January of each year." and

WHEREAS, the Bylaws of the Commission may be amended only after approval by

the Commission and with the concurrence of the Board of Commissioners and a majority of the municipalities participating in the Commission; and

WHEREAS, the Board of County Commissioners of Lorain County, Ohio, have by Resolution No. 68-466 approved said amendment to the Bylaws of the Commission; and

WHEREAS, the Council/~~Planning Commission~~ of the City/~~Village~~ of _____

Oberlin is aware of the value of the work performed by the (Lorain County) Regional Planning Commission and desires to maintain a strong level of planning at this regional level:

NOW THEREFORE BE IT RESOLVED THAT the Council/~~Planning Commission~~ of the City/~~Village~~ of Oberlin hereby approves the amendment to the Bylaws of the Regional Planning Commission passed by the Commission at its June 10th meeting which amendment raises the annual per capita membership fees for municipalities cooperating in the Commission from ten (10) to eighteen (18) cents per capita of its population according to the latest Federal Census or such governmental census as may be agreed upon between the Executive Committee of the Commission and the municipality; and

BE IT FURTHER RESOLVED THAT the Clerk of Council/~~Secretary of the Planning Commission~~ be instructed to certify a duly authenticated copy of this resolution to the office of the (Lorain County) Regional Planning Commission in Elyria, Ohio.
