AN ORDINANCE AMENDING THE ZONING CODE OF THE CITY OF OBERLIN DESIGNATING CERTAIN PROPERTY AS R-1-B RESIDENTIAL.

BE IT ORDAINED by the Council of the City of Oberlin, Lorain County, Ohio, a majority of members thereto concurring:

SECTION 1. The following described property is herewith open the effective date of this ordinance rezoned and described as R-1-B Residential.

Situated in the City of Oberlin, County of Lorain and State of Ohio, and known as being a part of Original Russia Township Lot No. 84, bounded and described as follows:

Beginning at a point in the center line of West College Street at the most Westerly corner of land conveyed to Robert A. Wohleber and Irene H. Wohleber, by Deed dated January 31, 1968 and recorded in Volume 960, Page 140 of Lorain County Deed Records; thence running Northeasterly in the Westerly line of land so conveyed to Robert A. Wohleber and Irene H. Wohleber, a distance of about 280 feet to the Northerly corner thereof; thence in a Northwesterly direction, parallel with the center line of West College Street, a distance of 150 feet to the Northeasterly corner of land conveyed to the Trustees for the West College Park Trust, by Deed dated January 6, 1969 and recorded in Volume 979, Page 115 of Lorain County Deed Records, said land being Parcel No. 2 of Exhibit 'A' of said Deed; thence Westerly along the Northerly line of Parcel No. 2 of Exhibit 'A' of said Deed, a distance of 180 feet to the Northeasterly corner of land conveyed to Trustees for the West College Park Trust, by Deed dated January 6, 1969 and recorded in Volume 979, Page 115 of Lorain County Deed Records, said land being Exhibit 'C' of said Deed; thence Westerly in a line parallel with the Northerly line of West College Street, a distance of 125 feet to a Southwesterly corner of land conveyed to William F. Gaeuman, by Deed dated March 25, 1969 and recorded in Volume 1001, Page 185 of Lorain County Deed Records; thence Southwesterly in said William F. Gaeuman's Easterly line, a distance of 150 feet to the Northerly line of West College Street; thence Southeasterly along the Northerly line of West College Street a distance of 125 feet to the Westerly line of land conveyed to the Trustees for the West College Park Trust, by Deed dated January 6, 1969 and recorded in Volume 979, Page 115 of Lorain County Deed Records, said land being Parcel No. 2 of Exhibit 'A' of said Deed; thence Southwesterly in said Trustees' Westerly line, a distance of 30 feet to the center line of West College Street; thence Southeasterly in the center line of West College Street, a distance of 300 feet to the place of beginning, be the same more or less, but subject to all legal highways.

SECTION 2. The public hearing for this rezoning shall be the 18th day of October, 1971

SECTION 3. This ordinance shall be in full force and effect from and after the earliest period allowed by law.
