AN ORDINANCE ACCEPTING THE ANNEXATION OF A. H. CLARK AND OTHERS FOR AREA IN RUSSIA TOWNSHIP TO BE ANNEXED TO THE CITY OF OBERLIN.

BE IT ORDAINED by the Council of the City of Oberlin, a majority of all members elected thereto concurring.

SECTION 1. That the application of A. H. Clark and others for annexation of the following described territory in the County of Lorain and adjacent to the City of Oberlin, to-wit:

"Situated in Russia Township, County of Lorain, and State of Ohio, and known as being part of Original Lots 88, 89 and 99, Russia Township, and bounded and described as follows:

Beginning at the Southwesterly corner of Original Lot 89 which point is also the Southeasterly corner of the Corporation line of the City of Oberlin;

Thence Northerly along the Westerly line of Original Lot 89 and along the Easterly corporation line of the City of Oberlin, a distance of about 2164.59 feet to the Southeasterly corner of land conveyed by the State of Ohio to the City of Oberlin by Deed dated June 6, 1966 and recorded in Vol. 927, Page 422 of Lorain County Deed Records;

Thence Northerly along the Westerly line of land so conveyed to Margaret L. Powers a distance of 220.00 feet to the Southerly line of the Cleveland-Oberlin Road, also known as State Route 10;

Thence Easterly along the Southerly line of the Cleveland-Oberlin Road, a distance of about 1032.46 feet to the Westerly line of land conveyed to Arthur S. Dudley by Deed dated September 18, 1963 and recorded in Vol. 857, Page 334 of Lorain Co. Deed Records;

Thence Southerly along the Westerly line of land so conveyed to Arthur S. Dudley a distance of about 2619.52 feet to the Southwesterly corner thereof which point is also the North line of Original Lot 99;

Thence Easterly along the Southerly line of land so conveyed to Arthur S. Dudley and along the Northelry line of Original Lot 99 a distance of about 221,42 feet to the Northwesterly corner of land conveyed to Henry Taylor by Deed dated August 25, 1970 and recorded in Vol. 1009, Page 513 of Lorain County Deed Records;

Thence Westerly along the Northerly line of Parsons Road to the Westerly line of Original Lot 99 which is also the Easterly line of land conveyed to James F. and May R. Bentley by Deed dated July 16, 1968 and recorded in Vol. 968, Page 69 of Lorain County Deed Records;

Thence Northerly along the Westerly line of Original Lot 99 and along the Easterly line of land so conveyed to James F. and May R. Bentley a distance of about 1650 feet to the Northeasterly corner thereof and the place of beginning of lands herein described and containing about 87.55 acres of land as described from available deed records by Laundon, Huffman and Simon, Registered Surveyors, July 14, 1971."
