BE IT ORDAINED by the Council of the City of Oberlin, Lorain County, Ohio, fivesevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. Section 927.01 is amended to read as follows:

927.01 ADMISSION TO LANDFILL

Solid waste disposal services at the Municipal Landfill shall be available to only Oberlin residents, commercial and industrial establishments within the City of Oberlin, Oberlin College, Oberlin Board of Education and contractors working on the behalf of any of the foregoing within the City limits. The landfill services shall also be available to the Ohio Department of Transportation Highway Division Garage and to nonresidents who pay Oberlin Income Tax.

SECTION 2. Section 927.02 is amended to read as follows:

927.02 RATE SCHEDULE

From and after the effective date of this ordinance there is herewith established a fee schedule for solid waste disposal services at the Municipal Landfill:

Type of Vehicle Admitted to Landfill	Fee/Per Trip
(a) Automobiles	No Charge
(b) Trucks, or automobiles with trailers, not exceeding 7049 lbs. net vehicle weight	\$ 3.00
(c) Trucks not exceeding 10,049 lbs. net vehicle weight	\$ 8.00
(d) Trucks exceeding 10,050 lbs. net vehicle weight	\$ 40.00
(e) Refuse Compactor Trucks	\$ 40.00

A permit shall be required for any use of the landfill facility and shall be issued by the Finance Department upon payment of any required fee and shall be surrendered to the landfill attendant prior to admission to the landfill.

SECTION 3. Section 927.03 is amended to read as follows:

927.03 EXCEPTIONS

The landfill admission fee established in Section 927.02 shall not apply to contractors hauling refuse and debris resulting from the construction of any City-owned improvement or from the demolition of buildings under condemnation by the City.

SECTION 4. Section 927.04 is amended to read as follows:

927.04 HOURS OF OPERATION

The municipal landfill shall be open to the public during the following hours:

Monday through Friday 12:00 Noon - 4:00 PM Thursday Night 4:00 PM - 7:00 PM or darkness Saturday 9:00 AM - 2:00 PM

SECTION 5. This ordinance shall be in full force and effect from and after the earliest period allowed by law.
