ORDINANCE NO. 1058 AC CMS

AN ORDINANCE AMENDING CHAPTER 373, CODIFIED
ORDINANCES

BE IT ORDAINED by the Council of the City of Oberlin, Lorain County, Ohio, a majority of all members elected thereto concurring:

SECTION 1. Section 373.13 of the Codified Ordinances of the City of Oberlin, Ohio, presently reading as follows:

373.13 APPLICATION: LICENSE TAG.

"The City shall provide suitable tags having the registration number thereon in numerical order for attachment on each bicycle. Such tags shall be attached to the front mast of the bicycle immediately below the seat. On tandem bicycles the front mast shall be the place where the tags shall be attached. The removal of any such tag, except by proper authority, shall be a violation of this chapter. The City shall also keep a record of the date of issuance of each license, the name and address and names of parents in each case of a minor applicant, of the person to whom the same is issued, who shall be the owner thereof, and also a record of the make and the manufacturer's number on each bicycle registered and the name of the dealer or person from whom the bicycle was purchased. The City shall issue an exact copy of the registration record to each applicant. (Ord. 88 AC, Passed 9-1-58),"

is amended to read as follows:

373.13 METALLIC LICENSE TAGS: REGISTRATION CARD

"The Police Department shall provide metallic license tags, together with registration cards, which tags and cards shall have numbers stamped thereon in numerical order beginning with number one and continuing year after year in numerical sequence, or a combination of numerals and letters as designated by the Police Department. Such tags shall be suitable for attachment upon the frame of bicycles. It shall be the duty of the Police Department to issue to each owner one tag, which shall be attached by the Police Department to the frame of the bicycle, and a corresponding registration card, upon payment of the license fee herein provided for. Such tag shall remain attached to the bicycle for which it was issued during the existence of such license, and for the duration of the ownership of the bicycle for which it was issued. The Police Department shall also keep a record of such registration. The operator of a bicycle shall display his registration card or produce satisfactory proof that he has such registration card, upon the demand of any officer of the Police Department all license tags and registration cards shall expire on the selling or trading of, junking of, or dismantling of the bicycle by the original owner. The Police Department shall inspect each bicycle so registered to insure it meets the minimum safety standards established by State and local law."

SECTION 2. Section 373.14 of the Codified Ordinances of Oberlin, Ohio, presently reading as follows:

373.14 TRANSFER OF LICENSE.

"The license shall not be transferable whenever the ownership of a bicycle is transferred to any other person. However, such license may be transferred to another bicycle at the election of the owner, but such transfer shall be registered and recorded at the City Hall within forty-eight hours after transfer. (1957 Code #373.14)."

is amended to read as follows:

373.14 DUPLICATE TAG OR REGISTRATION.

"In case of loss or destruction of a license tag or registration card, or if either of the same or both should become illegible, a replacement tag and/or registration card shall be issued, for the fee herein set forth, to the registered owner provided that such owner gives satisfactory proof to the Police Department of ownership either by affidavit or otherwise."

SECTION 3. Section 373.15 of the Codified Ordinances of Oberlin, Ohio, presently reading as follows:

373.15 LICENSE FEE.

"The license fee shall be one dollar (\$1.00) and shall be paid in advance. A license so issued shall be effective for a twelve-month period commencing on October 15 of each year. (Ord. 518 AC. Passed 5-15-67.)."

is amended to read as follows:

373.15 LICENSE AND TAG FEES.

The license fee for the registration card, tag and inspection shall be Two Dollars and Fifty Cents (\$2.50) for each bicycle and shall be paid to the Police Department at the time of the registration. Upon application for a replacement tag and/or registration card, in accordance with Section 373.14 each owner shall pay to the Police Department a fee of Two Dollars and Fifty Cents (\$2.50) for such replacement tag and duplicate card. A person acquiring a bicycle, either by purchase or other lawful means, shall within forty-eight hours after acquisition, register said bicycle with the Police Department as provided for herein.

SECTION 4. All existing ordinances or parts thereof that are in conflict with this ordinance are hereby repealed.

SECTION 5. This ordinance shall take effect from and after the earliest period allowed by law.
