

ORDINANCE NO. 1112 AC CMS

AN ORDINANCE AMENDING SECTION 507.102 (B) (1)
THROUGH (3) CODIFIED ORDINANCES OF THE CITY
OF OBERLIN

BE IT ORDAINED by the Council of the City of Oberlin, Lorain County, Ohio, a majority of all members elected thereto concurring:

SECTION 1. Section 507-102 (B) ~~o (1) through (3)~~ presently reading as follows:

"(B) Any person who violates Section (A) shall be subject to the following:

(1) If a dog is found to be running at large and wearing a Lorain County dog license or a collar with an identification tag, such dog need not be seized and impounded. However the owner, keeper or harbinger of such dog shall be sent, by first class mail, a notice of violation of dog law. (Ord. 64 AC. Passed 5-5-58).

(2) Such notice shall provide for appearance at the City Hall or any other place which may be designated for the purpose by the City Manager. If appearance is made within five days, the owner, keeper or harbinger shall be fined eight dollars (\$8.00) for the violation.

(3) If appearance is not made within the prescribed five days, then a summons for the appearance of the owner, keeper or harbinger shall be issued. Upon conviction, the penalty shall be fifteen dollars (\$15.00) and costs for the first offense, twenty dollars (\$20.00) and costs for the second offense and twenty-five dollars (\$25.00) and costs for each subsequent offense. (Ord. 764 AC. Passed 3-15-71),"

is hereby amended to read as follows:

"(B) Any person who violates Section (A) shall be subject to the following:

(1) If a dog is found to be running at large and wearing a Lorain County dog license or collar with an identification tag, such dog need not be seized and impounded. However, the owner, keeper or harbinger of such dog shall be sent, by first class mail, a notice of violation of dog laws. (Ord. 64 AC. Passed 5-5-58).

(2) If a dog found running at large cannot be seized whether or not it has a Lorain County Dog license or a collar with an identification tag, but can be identified, then the owner, keeper or harbinger of such dog shall be sent by first class mail a notice of the violation of dog laws.

(3) Such notice provided for by subsections (1) and (2) herein shall provide for appearance at the City Hall before the City Manager or other person designated by the City Manager. Upon conviction, the fine for a first

offense shall be \$10.00 if the appearance is made within five (5) days from date of said notice or if the appearance is not made within said five (5) days, then the fine shall be \$25.00.

within two years from the date of the first offense

For a second offense, the fine shall be \$15.00 if the appearance is made within five (5) days from date of said notice, or if the appearance is not made within said five (5) days, then the fine shall be \$30.00.

within two years from the date of the first offense

For a third offense, the fine shall be \$25.00 if the appearance is made within five (5) days from date of said notice or if the appearance is not made within said five (5) days, then the fine shall be \$35.00.

within two years from the date of the first offense

For a fourth or subsequent offense, the owner, keeper or harborer of such dog shall be summoned to appear in Court and if convicted shall be fined not less than \$45.00 nor more than \$100.00. No portion of the first \$45.00 of said fine shall be suspended by the Court."

SECTION 2. This Ordinance shall take effect from and after the earliest date allowed by law."
