ORDINANCE NO. 1126 AC CMS

AN ORDINANCE REPEALING ORDINANCE NO. 1061 AC CMS
AND AMENDING ORDINANCE NO. 119 AC CMS ESTABLISHING
ELECTRIC RATES FOR THE CITY OF OBERLIN, OHIO

BE IT ORDAINED by the Council of the City of Oberlin, Ohio,
a majority of all members elected thereto concurring:

SECTION 1. That Ordinance No. 1061 ACCMS is hereby repealed.

SECTION 2. That Section 1 of Ordinance No. 119 AC CMS is
hereby amended to read as follows:

"The following electrical rates for consumers of electrical
power produced by the City of Oberlin are hereby established:

A. Residential Service:

Applicable

This schedule is applicable to residential customers
for all domestic and household purposes as distinguish-
ed from commercial, professional and industrial pur-
poses.

Residences where not more than three (3) rooms are
regularly used for rental purposes will be included
hereunder. Residences where more than three (3)
rooms are regularly used for rental purposes will be
classified as rooming houses or dormitories and will
be served with the General Service Schedule (Commer-
cial). Where two or more families with separate
kitchen facilities occupy a residential building and
are served through a single meter, the customer shall
have the option of:

(1) arranging the wiring so that the service to each
family shall be separately metered;

(2) purchasing service under this schedule on a "per
apartment" basis, with the number of KWH in each
block of the rate and the minimum charge, multiplied
by the number of apartments; or

(3) purchasing service under the General Service
Schedule (Commercial).

Rates

6.60¢ per KWH for the first 20 KWH per month
5.10¢ per KWH for the next 40 KWH per month
4.00¢ per KWH for the next 40 KWH per month
2.65¢ per KWH for all over 100 KWH per month

Minimum Bill: \$1.35 per month

As an additional service, customers may subscribe for Yard Light Service for yard and area lighting only, to be installed in location accessible to maintenance truck only.

CHARACTER OF SERVICE:

A pole mounted lamp operated by a photoelectric control to furnish light from dusk to dawn.

RATE:

175 Watt, Approx. 7,000 lumen, \$4.30 per month
250 Watt, Approx. 12,000 lumen, \$6.05 per month
400 Watt, Approx. 22,000 lumen, \$7.75 per month

An additional charge of forty cents will be made for each additional pole and span of service required to connect yard light pole.

BILLING:

The billing will be added to the customer's regular monthly electric bill.

INSTALLATION AND MAINTENANCE:

The complete installation will be furnished and maintained by the Electric Department, including lamp bulb replacements.

B. Commercial Service:

Applicable

This schedule is applicable to all commercial customers for all lighting and/or power purposes. Each meter installation will be billed for separately. Not applicable to standby, breakdown, auxiliary or street lighting service.

Character of Service

AC, 60 cycle, single phase 120/240 volts; 3 phase 120/208 volts or 240 volts.

Demand Charge

No charge first 25 KVA demand.
\$2.00 per KW next 25 KVA demand.
\$1.35 per KW for all over 50 KVA demand.

Energy Charge

6.60¢ per KWH first	20 KWH
5.65¢ per KWH next	180 KWH
4.30¢ per KWH next	800 KWH
3.35¢ per KWH next	1,000 KWH
3.00¢ per KWH next	5,000 KWH
2.50¢ per KWH next	10,000 KWH
2.20¢ per KWH for all over	17,000 KWH

Minimum Bill

\$1.45 per KVA for highest billing demand established during preceeding 11 months, but not less than \$1.75 per single phase service and \$5.75 for 3-phase service.

Billing Demand

The highest 15 minute KVA demand measured by an integrating demand meter, ^{or} the highest reading taken on a thermal demand meter during the month or by periodic tests.

Seasonal Service

If a customer requests service discontinued because of seasonal service, the minimum will not be charged after service is discontinued. A charge of \$5.75 will be made when service is re-stored.

SECTION 3. This Ordinance shall be in full force and effect from and after the earliest period allowed by law.
