ORDINANCE NO. 1318 AC CMS

AN ORDINANCE ASSESSING COST FOR ABATING NUISANCE CAUSED BY NON-COMPLIANCE WITH SECTION 551.02 OF THE OBERLIN CODIFIED ORDINANCES FOR THE YEAR 1977

BE IT ORDAINED by the Council of the City of Oberlin, Lorain County, State of Ohio, a majority of those members elected thereto concurring:

SECTION 1. That this Council finds that the Code Administrator has abated certain nuisances after notifying the owners of the property on which each of said nuisances originated, and has reported the cost of such abatement, all in the manner provided by law, as follows:
