

ORDINANCE 1659 AC CMS

AN ORDINANCE AUTHORIZING CERTAIN AMENDMENTS TO THE
CONTRACT BETWEEN NOR-CON, INC. AND THE CITY OF OBERLIN RELATIVE
TO CDBG WATER MAIN IMPROVEMENT PROGRAM - SECTION J AND DECLARING
AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Oberlin, County of
Lorain, State of Ohio, 5/7's of all members elected thereto concurring:

SECTION 1. That the attached change order dated October 15,
1982, relative to the contract between the City of Oberlin and NOR-
CON, Inc. for water main improvements as part of the City of Oberlin
Community Development Block Grant Program are hereby authorized and
approved and the City Manager is hereby authorized to execute same.

SECTION 2. It is hereby found and determined that all formal
actions of this Council concerning or relating to the adoption of this
Ordinance were adopted in an open meeting of the Council and that all
deliberations of this Council and of any of its committees that resulted
in such formal action were in meetings open to the public in compliance
with all legal requirements, including Section 121.22 of the Ohio
Revised Code.


SECTION 3. That this ordinance is hereby declared to be an

wit:


"to insure timely completion of the CDBG water main improvement

Construction Bulletin No. 2

Gentlemen:

This Construction Bulletin will summarize and serve as an approval to a modification for the above referenced project.

To provide permanent driveway aprons, using consistent driveway material on City property, providing a neat appearance, driveway aprons shall be replaced with concrete.

The replacement of the driveway aprons shall be performed as described above at a contract additional cost of \$5,640, for an estimated 470 square yards of concrete drive replacement at a unit price of \$12.00 per square yard.

Due to this revision, 27 square yards of asphalt drive replacement shall be deleted at a unit price of \$10.00 per square yard for a contract deduction of \$270.00.


The total contract addition less the contract deduction as a result of this Construction Bulletin is \$5,370.

This revision was approved by Mr. Jack R. Meyers per direction of Mr. J. Chris Nielson, City Engineer, in a
