

ORDINANCE NO. 1694 AC CMS

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO NOTIFY OHIO EDISON COMPANY THAT THE CITY OF OBERLIN DESIRES TO CANCEL AND TERMINATE THAT CERTAIN AGREEMENT DATED MARCH 8, 1977, BETWEEN THE CITY OF OBERLIN AND OHIO EDISON COMPANY AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, 5/7ths of all members elected thereto concurring:

SECTION 1. That the City Manager is hereby authorized and directed to give immediate notice to Ohio Edison Company that the City desires to cancel and terminate that certain agreement dated March 8, 1977, between the City of Oberlin and Ohio Edison Company relative to the furnishing of electrical service to the City and setting the price to be charged therefor.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, to-wit:

"to insure timely notice of cancellation of said contract pursuant to the terms contained therein"

and shall go into effect immediately upon passage.

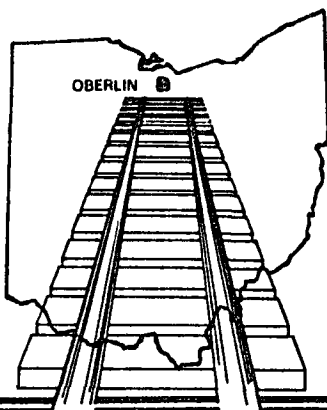
