

ORDINANCE NO. 87-74 AC CMS

AN ORDINANCE ACCEPTING BIDS FOR CHEMICALS USED IN THE WATER TREATMENT  
AND WASTEWATER TREATMENT PLANTS OF THE CITY OF OBERLIN, OHIO,  
FOR THE YEAR 1988

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain,  
State of Ohio, a majority of all members elected thereto concurring:
