

RESOLUTION NO. R88-7 CMS

A RESOLUTION AUTHORIZING THE CITY MANAGER OF OBERLIN, OHIO,
TO PARTICIPATE IN COOPERATIVE PURCHASING CONTRACTS WITH
THE STATE OF OHIO, PURSUANT TO SECTION 125.04
OF THE OHIO REVISED CODE

WHEREAS, Ohio's Cooperative Purchasing Act (Am. Sub. H.B. No. 100) was signed into law by Governor Richard F. Celeste on December 4, 1985; and

WHEREAS, effective March 6, 1986, Ohio's Cooperative Purchasing Act provides the opportunity for counties, townships, municipal corporations and school districts to participate in contracts of the State of Ohio, Department of Administrative Services, Office of State Purchasing for the purchase of supplies, services, equipment and certain materials.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the City Manager of the City of Oberlin, Ohio, hereby requests authority in the name of the City of Oberlin, Ohio, to participate in state contracts which the Department of Administrative Services, Office of State Purchasing has entered into for the purchase of supplies, services, equipment and certain materials pursuant to Revised Code Section 125.04.

SECTION 2. That the City Manager is hereby authorized to agree in the name of the City of Oberlin, Ohio, to be bound by all contract terms and conditions as the Department of Administrative Service, Office of State Purchasing prescribes. Such terms and conditions may include a reasonable fee to cover the administrative costs which the Department of Administrative Services incurs as a result of the City of Oberlin's participation in a contract. Further, that the City Manager does hereby agree to be bound by all such terms and conditions.

SECTION 3. That the City Manager is hereby authorized to agree in the name of the City of Oberlin, Ohio, to directly pay the vendor, under each such state contract in which it participates, for items it receives pursuant to the contract, and the City Manager does hereby agree to directly pay the vendor.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this resolution were adopted in an open meeting of the Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That this resolution shall take effect at the earliest date allowed by law.
