

ORDINANCE NO. 92-86 AC CMS

AN ORDINANCE DECLARING CERTAIN PROPERTY SURPLUS AND NO LONGER SUITABLE OR NECESSARY FOR ANY MUNICIPAL PURPOSE

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. The following property belonging to the City of Oberlin is hereby declared surplus property and no longer suitable or necessary for any municipal purpose and the City Manager is hereby authorized and directed to advertise same for sale in a newspaper of general circulation in the City for not less than two (2) consecutive weeks.
