ORDINANCE NO. 93-11 AC CMS

AN ORDINANCE AMENDING SECTION 351.99
CODIFIED ORDINANCES - CITY OF OBERLIN, OHIO,
RELATING TO THE SCHEDULE OF PARKING FINES WITHIN THE CITY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That Section 351.99 of the Codified Ordinances of the City of Oberlin, Ohio, relating to the schedule of fines for parking violations within the City be, and hereby is, amended to read as follows:

351.99 PENALTY AND WAIVER

31

- (a) Whoever violates any provision of this chapter shall be fined not more than one hundred dollars (\$100.00).
- (b) Whoever is charged with the violation of any parking provision of this chapter, wherein a traffic ticket is issued may, in lieu of being charged in court on an affidavit and subject to the penalty provided in subsection (a) hereof deliver the traffic ticket to the City Hall and pay a fine as follows:

FOR A VIOLATION IN A C-1 DISTRICT

- (1) Five dollars (\$5.00) for a 1st or 2nd violation within any one (1) calendar year.
- (2) Twenty dollars (\$20.00) for a 3rd violation within any one (1) calendar year.
- (3) Forty dollars (\$40.00) for a 4th violation within any one (1) calendar year.
- (4) Fifty dollars (\$50.00) for a 5th violation within any one (1) calendar year.
- (5) If more than five (5) violations in any one (1) calendar year, or if the fine is not paid within 30 days, the offender shall be cited to Municipal Court.
- (6) Any such payment of the ticket shall be deemed a plea of guilty, waiver of court appearance and an acknowledgment of the conviction of violation as set forth in subsection (a) set forth hereinbefore.

FOR A VIOLATION OTHER THAN IN A C-1 DISTRICT

- (1) Five dollars (\$5.00) if the violation is paid within seventy-two hours.
- (2) If paid after seventy-two hours, but within thirty days, the fine shall be ten dollars (\$10.00).
- (3) If not paid within thirty days, the City shall proceed with a formal charge and the violation shall be subject to a fine of not more than fifty dollars (\$100.00).
- (4) Any such payment of the citation shall be deemed a plea of guilty, waiver of court appearance and an acknowledgement of the conviction of the alleged offense and may be accepted in full satisfaction by the City for the subscribed penalty for such alleged violation as set forth in subsection (a) hereof.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance shall take effect at the earliest date allowed by law.
