

ORDINANCE NO. 93-25 AC CMS

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER
INTO A CONTRACT WITH THE OBERLIN WEEKDAY HOT MEALS PROGRAM
FOR THE PROVIDING OF HOT MEALS TO NEEDY INDIVIDUALS
WITHIN THE CITY OF OBERLIN

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the City Manager is hereby authorized and directed to enter into a contract with the Oberlin Weekday Hot Meals Program for the providing of hot meals to needy individuals within the City of Oberlin for the 1993 calendar year.


SECTION 2. That in exchange for the furnishing of said services to needy individuals, the City hereby authorizes the expenditure of \$925.00.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 4. That this ordinance shall take effect at the earliest date allowed by law.

A G R E E M E N T

This Agreement made and concluded at Oberlin, Ohio, this
____ 19th ____ day of ____ April _____, 1993, by and between the
City of Oberlin, a municipal corporation (hereinafter referred to
as CITY), and the Oberlin Weekday Hot Meals Program (hereinafter
referred to as HOT MEALS PROGRAM),

W I T N E S S E T H:

WHEREAS, the CITY has the authority to provide assistance to
residents of the Oberlin Community who, due to low income,
disability, or other social need, require the provision of
nutritional meals; and,

WHEREAS, the CITY desires to help provide nutritional meals to
said needy individuals; and,

WHEREAS, the Council of the CITY has, by Ordinance No.
93-25 AC CMS, deemed it necessary to authorize the City Manager to
enter into an Agreement with the Oberlin Weekday Hot Meals Program,
whereby said Program will provide such nutritional assistance to
said needy individuals on behalf of the CITY; and,

WHEREAS, the CITY in return for the providing of said
nutritional meals to needy individuals by said HOT MEALS PROGRAM,
will provide financial assistance to said Program.

NOW, THEREFORE, in consideration of the premises and other valuable consideration, it is agreed by and between the parties hereto as follows:

SECTION 1. That for the year 1993, the HOT MEALS PROGRAM will operate a weekday hot meals program for residents of the City of Oberlin who are "needy" as defined by the by-laws of said Program.

SECTION 2. In exchange for the provision of said weekday hot meals to the citizens of the City of Oberlin, the CITY agrees to provide the sum of NINE HUNDRED TWENTY-FIVE DOLLARS (\$925.00) for the 1993 calendar year to said HOT MEALS PROGRAM to assist them in carrying out their duties as set forth in their by-laws.

SECTION 3. Upon request, the HOT MEALS PROGRAM will provide the CITY with periodic reports, and will allow the CITY to review its financial records, in order to assure the CITY that the services contemplated are, in fact, being satisfactorily and efficiently provided.

SECTION 4. The HOT MEALS PROGRAM agrees to hold harmless and indemnify the CITY from any and all losses, claims, damages, and judgements arising out of or resulting from the operation of said HOT MEALS PROGRAM.
