AN ORDINANCE ACCEPTING THE BID OF LANPHEAR SUPPLY, OF SOUTH EUCLID, OHIO, FOR A BRUSH CHIPPER FOR THE PUBLIC WORKS DEPARTMENT AND DECLARING AN EMERGENCY
