ORDINANCE NO. 94-84 AC CMS

AN ORDINANCE DETERMINING CERTAIN REAL PROPERTY
OWNED BY THE CITY OF OBERLIN, OHIO, NOT NECESSARY
FOR ANY CURRENT MUNICIPAL PURPOSE AND
AUTHORIZING THE TRANSFER OF SAME TO THE
OBERLIN COMMUNITY IMPROVEMENT CORPORATION

WHEREAS, the City of Oberlin is the owner of a .59 acre parcel of unimproved real property located adjacent to Artino Street in the City of Oberlin; and,

WHEREAS, said real property is unbuildable and consists mainly of ditch and drainage area and is, therefore, of nominal value and not necessary for any current municipal purpose; and,

WHEREAS, it is in the interests of the City of Oberlin to transfer said real property to the Oberlin Community Improvement Corporation to allow that non-profit organization to utilize the property, in furtherance of commercial and industrial development in the City.

NOW THEREFORE BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the .59 acre parcel of unimproved real property adjacent to Artino Street in the City of Oberlin, and described in Exhibit A attached hereto, is hereby declared surplus and not necessary for any current municipal purpose.

SECTION 2. That the City Manager is hereby authorized and directed to prepare and execute a Quit Claim Deed for said real property transferring same to the Oberlin Community Improvement Corporation, to be utilized by that community organization in furtherance of its mission to stimulate commercial and industrial development in the City.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance shall take effect at the earliest date allowed by law.
