ORDINANCE NO. 95-69 AC CMS

AN ORDINANCE AMENDING SECTION 911.11 OF THE CODIFIED ORDINANCES OF THE CITY OF OBERLIN, OHIO, WHICH PROVIDES FOR WATER RATES FOR THE CITY OF OBERLIN, OHIO

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That Section 911.11 of the Codified Ordinances of the City of Oberlin, Ohio, which provides for water rates for the City of Oberlin, Ohio, be, and hereby is amended to read as follows:

911.11 Water Rates

- (a) The water service charge shall be based on water use. The rate for all bills rendered on or after February 1st of each ensuing twelve-month period, beginning February 1, 1996, shall be as set forth hereafter.
- (b) Definitions.
 - (1) "WR" means water rate, in dollars per 100 cubic feet, for users within the City.
 - (2) "Q" means water usage, in 100-cubic-foot units, as calculated from water sale revenues received for the calendar year immediately prior to the year in which the rate is to take effect.
 - (3) "OM" means operation and maintenance appropriation.
 - (4) "D" means debt service appropriations; principal and interest due on current obligations.
 - (5) "C" means capital expense appropriations.
 - (6) "R" means water system reserve appropriations.
- (c) The basic water rate shall be:

$$WR = \frac{OM + D + C + R}{Q}$$

- (d) Billing.
 - (1) Bills for water service will be rendered monthly.

- (2) The water used by the same person, firm or corporation, but delivered and metered separately or at different locations, will not be combined for billing purposes.
- (3) The City will make available upon the request of a residential customer a plan for uniform monthly payments for water service over specified periods.

The water rate for users outside the city shall be one and one-half times the basic rate.

The minimum bill shall be calculated from minimum usage of three 100-cubic-foot units of water per month. (Ord. 86-3AC. Passed 2-18-86)

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance shall take effect at the earliest date allowed by law.
