

RESOLUTION R95-8

A RESOLUTION AUTHORIZING THE CITY MANAGER TO FILE AN APPLICATION AND ENTER INTO AGREEMENT WITH THE LORAIN COUNTY BOARD OF COMMISSIONERS THROUGH THE LORAIN COUNTY SOLID WASTE MANAGEMENT DISTRICT FOR THE PURPOSE OF ACQUIRING FUNDS THROUGH THE RECYCLING AND COMPOSTING GRANT PROGRAM PURSUANT TO THE LORAIN COUNTY SOLID WASTE PLAN

WHEREAS, Oberlin City Council recognizes the existence of a problem with recycling/composting within the boundaries of the City and the need to address the problem at the local level; and,

WHEREAS, the Lorain County Board of Commissioners provides through the Lorain County Solid Waste Management District Plan for the purpose of allocation of funds in the form of grants for the purposes of supplemental recycling/composting programs.

NOW, THEREFORE, BE IT RESOLVED BY the Council of The City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the Oberlin City Council hereby endorses and supports a Recycling/composting Program for the City of Oberlin, and authorizes the necessary funds to implement said program, if approved, as indicated in its application.

SECTION 2. That the City Manager is hereby authorized to apply for and, if awarded, enter into an agreement with the Lorain County Solid Waste Management District to administer a grant to implement said program, and that the City Manager is hereby authorized to sign said agreement.

SECTION 3. That the Oberlin City Council hereby requests the Lorain County Solid Waste Management District to consider and fund its program as described in the application.

SECTION 4. That it is hereby found and determined that all formal actions of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
