AN ORDINANCE ACCEPTING THE BID OF
POTTINGER AND COMPANY, OF DAYTON, OHIO FOR GENERAL
LIABILITY, LAW ENFORCEMENT LIABILITY, PUBLIC OFFICIALS
LIABILITY, FIREMAN'S ERROR & OMISSIONS, AND AUTOMOBILE
LIABILITY INSURANCE COVERAGE FOR THE CITY OF OBERLIN
AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A
CONTRACT AND DECLARING AN EMERGENCY

SECTION 1. That the bid of the following insurance company and its agent, being the lowest and best bid for supplying certain insurance coverage for the City of Oberlin, be and the same is hereby accepted, and the City Manager is authorized to enter into a contract accordingly:
