

ORDINANCE NO. 98-5 AC CMS

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO  
A CONTRACT WITH THE OBERLIN AREA CHAMBER OF COMMERCE  
TO PROVIDE PROMOTIONAL ACTIVITIES TO THE CITY OF OBERLIN, OHIO

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain,  
State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the City Manager is hereby authorized and directed to  
enter into a contract with the Oberlin Area Chamber of Commerce for the  
providing of promotional activities for the City of Oberlin, in accordance with  
the proposal previously submitted to the City, a copy hereby attached hereto  
and incorporated herein by reference, and in the amount of \$41,000.

SECTION 2. It is hereby found and determined that all formal actions of  
this Council concerning or relating to the adoption of this ordinance were  
adopted in an open meeting of this Council and that all deliberations of this  
Council and of any of its committees that resulted in such formal action, were  
in meetings open to the public in compliance with all legal requirements,  
including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance shall take effect at the earliest date  
allowed by law.

## **AGREEMENT**

This Agreement made and concluded at Oberlin, Ohio, this 11<sup>th</sup> day of Feb, 1998, by and between the City of Oberlin, a municipal corporation (hereinafter referred to as "City"), and the "Oberlin Area Chamber of Commerce" an Ohio non-profit entity, (hereinafter referred to as "Provider").

WHEREAS, the City has revenue available, raised by the Bed Tax Ordinance, for purposes of the promotion of the City of Oberlin; and

WHEREAS, the Council of the "City" has by Ordinance No. 98-5, effective Feb, 2, 1998, authorized the City Manager to enter into an agreement with the Provider whereby the Provider will utilize FORTY-ONE THOUSAND DOLLARS (\$41,000.00) of the Bed Tax revenue funds for promotion of Oberlin and will provide the service to the City as shown in the attachment incorporated herein by reference.

NOW THEREFORE, in consideration of the promise contained herein and other valuable consideration it is agreed by the parties hereto as follows:

SECTION 1. That for the year 1998 the Provider will promote the City of Oberlin in the various ways and methods set forth hereinafter, and in further accordance with their proposal previously submitted to the City, said proposal and outline being incorporated herein by reference:

<b>Uncommon Objects</b>	<b>\$ 2,000</b>
<b>Oberlin Community Theater</b>	<b>\$ 2,500</b>
<b>Arts In Oberlin</b>	<b>\$ 2,000</b>
<b>Other</b>	<b>\$ 4,000</b>

**SECTION 2.** The City, in consideration of said services so provided will pay the Provider the sum of FORTY-ONE THOUSAND DOLLARS (\$41,000.00) for the year 1998 as set forth above.

**SECTION 3.** The Provider shall provide the City with a written report every three (3) months beginning with April 1, 1998, and followed by written reports on August 1, 1998, and January 1, 1999, specifically itemizing expenditures in the use of said funds provided to the Provider by the City.

**SECTION 4.** That the City shall have a right to demand and receive such other information from the Provider detailing the activities as found necessary by the City.
