- To be bound by the terms and conditions of the contract.
- To be responsible for payment directly to the vendor for the quantities purchased under the contract.

By signing and returning this agreement, you will be bound to participate in this contract during the 1998 - 1999 winter season, upon award of the contract to a successful vendor. A participating Political Subdivision cannot change its position during this contract period. Termination of participation is effective upon the expiration date of the contract. Failure of a Political Subdivision to purchase its requirements from the awarded vendor shall invalidate participation for the following winter season.

Political subdivisions will be required to submit a new participation agreement form every year, indicating storage capacity and stating salt needs for the contract period.
