ORDINANCE NO. 99-19 AC CMS

AN ORDINANCE AUTHORIZING THE PAYMENT OF \$69,043.54 TO THE POLICE AND FIREMEN'S DISABILITY AND PENSION FUND TO DISCHARGE ACCRUED BUT UNPAID LIABILITY AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the City Auditor is hereby authorized to make a payment of \$69,043.54 to the Police and Firemen's Disability and Pension Fund via a wire transfer to discharge accrued but unpaid liability, which will result in a cash discount to the City of \$30,622.37, in accordance with the correspondence received from the Police and Firemen's Disability and Pension Fund dated February 24, 1999, and attached hereto.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared an emergency measure necessary for the preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, to wit:

"to pay off an accrued liability to the Police and Firemen's Disability and Pension Fund on or before March 3, 1999, in order to receive the benefit of a large discount" and shall take effect immediately upon passage.
