ORDINANCE NO. 99-75 AC CMS

AN ORDINANCE AMENDING ORDINANCE NO. 99-62 AC CMS, WHICH AUTHORIZED THE CITY MANAGER TO ENTER INTO A CONTRACT WITH 32 FORD MERCURY, INC., OF BATAVIA, OHIO, FOR THE PURCHASE OF AN F-350 FORD CAB/CHASSIS WITH A DUMP BODY, SNOW PLOW AND BALL/PINTLE HITCH FOR THE OBERLIN MUNICIPAL LIGHT AND POWER SYSTEM AND DECLARING AN EMERGENCY

WHEREAS, on September 7, 1999, the City of Oberlin, Ohio, by Ordinance No. 99-62 AC CMS, authorized the City Manager to enter into a contract with 32 Ford Mercury, Inc., of Batavia, Ohio, for the purchase of a vehicle for the Oberlin Municipal Light & Power System; and

WHEREAS, the vehicle to be purchased must include certain options which were not specified in the purchase price as set forth in Ordinance No. 99-62 AC CMS; and

WHEREAS, it is necessary to amend Ordinance No. 99-62 AC CMS, to ensure the inclusion of the options required by the Oberlin Municipal Light & Power System and authorize the expenditure of additional funds to pay for them.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That Section 1 of Ordinance No. 99-62 AC CMS, is hereby amended to read as follows:

"Section 1. That pursuant to Ohio Revised Code Section 125.04 and City of Oberlin Resolution No. R88-7, the City Manager is hereby authorized and directed to enter into a contract with 32 Ford Mercury, Inc., of Batavia, Ohio, for the purchase of an F-350 Ford cab/chassis with a dump body, snow plow and ball/pintle hitch, including a central hydraulic system, electric trailer brake and chassis mount tool box for the Oberlin Municipal Light & Power System for a purchase price of \$37,055, plus a \$500 delivery charge to Johnson's Driveway Service".

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health, and safety of the citizens of the City of Oberlin, Ohio, to wit:

"to authorize the purchase of a truck with snow plow for the Oberlin Municipal Light & Power System as soon as possible to ensure the efficient operation of the Oberlin Municipal Light & Power System and protection and safety of the citizens of the City of Oberlin",

and shall take effect immediately upon passage.
