AN ORDINANCE ACCEPTING THE PROPOSAL OF ACCORDIA- POTTINGER AND COMPANY OF DAYTON, OHIO, FOR GENERAL LIABILITY, LAW ENFORCEMENT LIABILITY, PUBLIC OFFICIALS LIABILITY, FIREMEN'S ERRORS & OMISSIONS LIABILITY, AND AUTOMOBILE LIABILITY INSURANCE COVERAGE FOR THE CITY OF OBERLIN AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT AND DECLARING AN EMERGENCY
