ORDINANCE NO. 01-28 AC CMS

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH BOB ROSS BUICK GMC OF CENTERVILLE, OHIO, THROUGH THE STATE OFFICE OF PURCHASING FOR THE PURCHASE OF A PICK-UP TRUCK FOR THE PUBLIC WORKS DEPARTMENT AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That pursuant to Ohio Revised Code Section 125.04 and City of Oberlin Resolution No. R88-7, the City Manager is hereby authorized and directed to enter into a contract with Bob Ross Buick GMC of Centerville, Ohio, for the purchase of a Pick-up Truck for the Public Works Department for a purchase price of \$14,926.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, safety, and welfare of the citizens of Oberlin, Ohio, to wit:

"to authorize the purchase of a pick-up truck for the Public Works Department as soon as possible to ensure efficient operation of the Public Works Department", and shall take effect immediately upon passage.
