AN ORDINANCE AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH QUALITY CONTROL INSPECTION, INC. (QCI) OF BEDFORD, OHIO, FOR CONTRACT ADMINISTRATION AND RESIDENT PROJECT INSPECTION SERVICES FOR THE CITY OF OBERLIN AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain. State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. The contract with Quality Control Inspections, Inc. (QCI), of Bedford, Ohio, for contract administration and resident inspection services for the City of Oberlin, as previously approved by Ordinance No. 02-53 AC CMS, is hereby amended to authorize additional payment for additional services, in accordance with Section 2 set forth hereinafter.

SECTION 2. That the projects for which said services shall be utilized, and the maximum fees to be charged are as follows:

SECTION 3. "to authorize additional inspection and testing services as soon as possible in order to facilitate the construction of additional housing in the City" and shall take effect immediately upon passage.

RE: Amendment of Ordinance 03-42

Ordinance 03-42 authorized amendment to the Quality Control, Inc. construction administration and resident inspection services contract previously authorized by Ordinance 02-53. The three projects included are East Hamilton St. water line, Glonhurst Drive and Reamer/South St. utilities and paving. I derived the actual amount of the allocation for each project as a percentage (approximately 3.5%) of the total contract price for each project. The amount is based on previous inspection services fees incurred under the contract with QCI.

Both the East Hamilton St. water line project and Glenhurst Drive are substantially complete. Utility construction on South St. began last week. At this writing, I estimate that the City has incurred about \$15,000 (about 65%) of expenses authorized under 03-42. Inspection service costs for East Hamilton St. have been higher than anticipated. Unforeseen utility conflicts (storm water, loop detector and gas lines) have led to additional inspection hours. Our contractor, Eric Blacktop has gone to a (4)—10 hour day schedule. As a result overtime payments to QCI have increased by at least \$1,000. In order to ensure, proper payment for necessary inspection services, it will be necessary to amend Ordinance 03-42.

My recommendation is to increase the amount of the QCI contract for inspection services to \$32,000 to be allocated as follows:

The additional proposed funding should be available in this years' income tax fund budget for capital projects since Public Works Department projects are substantially under budget. The QCI inspectors have a good working relationship both with staff and with our Contractors. We are very satisfied with the service provided and we believe that funding spent is well worth the investment to ensure improvements are built and billed correctly. QCI has agreed to monitor the budgets on a weekly basis and to keep me informed of the status.

Per our phone conversation and the ordinance which I faxed to you, City Council has authorized the extension of the existing contract based on the following per project cost allocations:

Reamer/South utilities and pavung:	\$13,100
Glenhurst Drive:	\$6,250
E. Hamilton St. water line:	\$4,2 <u>00</u>
Total:	\$23,550

Based on the notes of the City Solicitor, Council has approved the referenced amounts in the particular and in aggregate. That is, no project is authorized to go over the proposed allocation and cumulatively the projects cannot go over the total authorized amount.

The only invoice to date (through July 25th) for the E. Hamilton St. water line project indicates an inspection services cost of \$6,061.83. At this time, I am not authorized to pay this amount.

In order to rectify this situation, I will need your assistance to review the proposed allocations for each of the above referenced projects. My goal is a re-allocation of the total authorized amount of \$23,550 between the three projects without going over. I'll need your recommendation on whether or not this is feasible and what amounts (per project) you would propose. At this time, I know that the City Manager is opposed to returning to City Council to increase the total authorization.

The next City Council meeting is scheduled for August 18th. In order to get this on the agenda, a proposed re-allocation must be forwarded to the City Manager by the end of the day today. If not, this will need to wait for the meeting scheduled for Tuesday, September 2nd.
