

ORDINANCE NO. 03-85 AC CMS

AN ORDINANCE AMENDING SECTION 1357.08 OF THE CODIFIED ORDINANCES OF THE CITY OF OBERLIN AS IT RELATES TO THE COMPOSITION OF THE MEMBERS OF THE DESIGN REVIEW SUBCOMMITTEE OF THE PLANNING COMMISSION

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That Section 1357.08 of the Codified Ordinances of the City of Oberlin as it relates to the composition of the Design Review Subcommittee of the Planning Commission is hereby amended to read as follows:

"1357.08 DESIGN REVIEW SUBCOMMITTEE OF THE PLANNING COMMISSION.

The Design Review Subcommittee of the Planning Commission shall consist of seven members. Two members shall be appointed from the Planning Commission. One member shall be recommended by the Chair of the Planning Commission for appointment by the Chair of Council. One member shall be appointed from the Historic Preservation Commission. One member shall be appointed from the Open Space Commission. *One member shall be appointed by the Board of Main Street Oberlin, Inc.* One member shall be appointed by Council. The respective Commissions shall, at their last scheduled meeting of each year, appoint their respective members of the Subcommittee of the Planning Commission for a term extending through the next succeeding year.

The Subcommittee of the Planning Commission shall hold at least one meeting annually, in January of each year, for the purposes of organizing and for review of any matters referred by the Director of Planning and Development or the Planning Commission. Additional meetings shall be held as agreed by the members and as required by this section. Meetings shall be open to the public. Attendance by a majority of the Subcommittee of the Planning Commission members shall constitute a quorum for conducting business. Recommendations and other actions shall be made by vote of the majority of members in attendance.

The Subcommittee of the Planning Commission shall adopt such rules and bylaws for the conduct of its business, as it shall deem necessary."

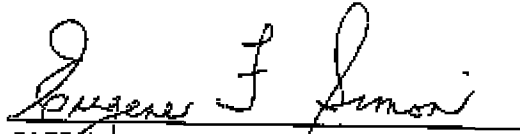
