AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH STATEWIDE FORD LINCOLN MERCURY INC OF VAN WERT OHIO THROUGH THE STATE OFFICE OF PURCHASING FOR THE PURCHASE OF TWO POLICE VEHICLES FOR THE OBERLIN POLICE DEPARTMENT AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin County of Lorain State of Ohio five sevenths (5/7ths) of all members elected thereto concurring

SECTION 1 That pursuant to Ohio Revised Code Section 125 04 and City of Oberlin Resolution No R88 7 the City Manager is hereby authorized and directed to enter into a contract with Statewide Ford Lincoln Mercury Inc. of Van Wert. Ohio for the purchase of two 2006 Crown Victoria Police Interceptor Vehicles for the Oberlin Police Department for the purchase price of \$41 272 (\$20 636 each).

SECTION 2 It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121 22 of the Ohio Revised Code

SECTION 3 That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace health and safety of the citizens of the City of Oberlin Ohio or to provide for the usual daily operation of a municipal department to wit

to authorize the purchase of two police vehicles as soon as possible to ensure the efficient operation of the police department and shall take effect immediately upon passage

I am requesting an ordinance be presented to Council authorizing the City to enter into an agreement with State-Wide Ford for the purchase of two 2006 Ford Crown Victoria Police Cruisers

Council had agreed to the purchase of one cruiser as part of the 2006 Police Capital budget to replace an older vehicle. It became necessary to order a second cruiser as one of our fleet was wrecked enroute to the shooting call at the Certified station.

The wrecked cruiser will be paid for from the insurance claim however since the two vehicles are being ordered from one vendor and the price exceeds \$25 000 00 an ordinance is required

State-Wide Ford was awarded the state bid again this year. Ohio State Contract OT909004. The price for the 2006 cruiser is the same as the 2005 cruiser last year.

Again we are requesting an ordinance to allow us to order two cruisers on the state contract. One cruiser was budgeted for in my capital budget, the second is to replace a wrecked cruiser and will be paid from the insurance claim.
