# AN ORDINANCE AMENDING SECTION 1329.03 OF THE CODIFIED ORDINANCES AND ADDING A SECTION 1329.06

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That Section 1329.03 of the Codified Ordinances entitled "Classification of Annexed Land", is hereby amended to read as set forth in Exhibit A attached hereto and incorporated herein by reference.

SECTION 2. That Section 1329.06, titled "Annexation Agreement with Pittsfield Township", as set forth in Exhibit B attached hereto and incorporated herein by reference, is hereby added to Chapter 1329 of the Codified Ordinances.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance shall take effect at the earliest date allowed by law.

All territory which may be annexed to the City, except any land that is located within the District created by the Annexation Agreement between the City and Pittsfield Township as referred to in Section 1329.06 of this Chapter, shall be classified as an "R-1A" District and subject to all conditions stipulated under such district, unless otherwise determined by ordinance.
