AN ORDINANCE ACCEPTING THE BID OF BUCKEYE EXCAVATING AND CONSTRUCTION, INC., OF SANDUSKY, OHIO, FOR THE CONSTRUCTION OF A SANITARY SEWER SERVICE LINE TO THE OBERLIN SERVICE COMPLEX IN THE CITY OF OBERLIN, OHIO, AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the bid of Buckeye Excavating and Construction, Inc., of Sandusky, Ohio, for the construction of a sanitary sewer service line to the Oberlin Service Complex in the City of Oberlin, Ohio, being the lowest and best bid submitted, is hereby accepted, and the City Manager is hereby authorized and directed to enter into a contract accordingly, said bid being in the amount of \$69,964.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared an emergency measure necessary for the preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit:

"to accept a bid within the time limitations provided by law", and shall take effect immediately upon passage.

On November 16th, the Public Works Department opened bids for the construction of sanitary sewer service to the new Service Complex. This is Phase II of the public improvements serving the site. Phase I included the street through the base asphalt course, the water main, and storm water facilities. Phase III, the final paving course, will follow completion of the Service Center.

The proposed construction begins at a newly installed manhole on the Service Complex site. A new 8" sanitary sewer line will gravity flow approximately 300' west in the south R/W to a new pump station. The pump station will be wired back to the electrical service in the Service Complex to connect to the back-up generator at this facility. From the pump station a 2" force main will be installed under the creek, to a new valve box near the intersection with Oberlin Rd. and then southwesterly across Oberlin Rd. to a new manhole connected to the existing sewer.

City Engineer Keith Johnson's published cost estimate for this project is \$65,000. We received three bids for this project as itemized below and on the attached bid tab sheet.

Buckeye Excavating, Inc	\$69,964.00
N & N Construction	
KMU Trucking and Excavating, Inc	\$89,119.00

The Code Administrator has approved the EEO packages for all bidders (copy attached).

Although we have worked with Buckeye Excavating on several projects, these have not included the installation of a pump station. The City Engineer checked references for this type of work provided with the bid. These all reported favorably on Buckeye Excavating's performance. The Public Works Department recommends that this contract be awarded to Buckeye Excavating, Inc. of Norwalk, OH in the amount of \$69,964.00.

As sanitary sewer service will soon be required at the Service Complex, I recommend passing this ordinance on emergency to ensure the usual daily operations of the Department. If there are any questions, please let me know.
