There are lots of good things happening in our part of the County such as the Viva White Oak development. And there is the encouraging news that the County is now starting to address some of our problem areas such as education, transportation and employment. Look at some of the projects that are currently in the works:

Jobs requiring various skills and education:

Visa White Oak, White Oak Medical Center (WOMC), Hilton Hotel, Hillandale Gateway, FDA, and three senior housing centers. Work Force Montgomery works to match jobs and workers, and getting foreign education accepted.

Restaurants and entertainment:

Viva White Oak.

Transportation:

Bus Rapid Transit (BRT) initially on US29 but eventually adding New Hampshire Ave and Randolph Road. Improved local buses to take people between home, work, activity centers and BRT stations. Also coming are intersection improvements, new bikeways and better walking connections.

Improved healthcare, both locally and beyond:

WOMC, FDA and the effort to attract LifeSci companies to Viva White Oak

Improved education to help students be ready to learn and to help our dedicated teachers with students who are not ready:

MCPS pre-K and volunteer program (see separate article), ESOL and college classes for adults (Montgomery College), and Strathmore programs (see www.strathmore.org/bloom/fovconnect)

Services:

DHHS service coordinator (see two separate articles)

Our monthly GCCA meetings are open to everyone. They provide a means to learn what is going on, how you can help in our community, and express your opinion on issues we discuss. Improving Public School Student Performance

A number of students in the public schools are not ready to learn when they enter school. Our wonderful teachers are doing everything they can to overcome this limitation, but that takes time.

Countywide, only 48% of the students in third grade met or exceed standards in English, and 54% achieved that level in math. Of the 15 elementary schools in our area, only four exceeded the county average for English and the same four for math. The school with the lowest scores has 11% of the students that met or exceeds the standard for English, and another school has 21% for math. A large percentage of those that fail to meet the standard are at the lowest level, "do not meet the standards" as opposed to the other two levels "partially" or "approaching" the standards.

Montgomery County Public Schools (MCPS) and the county have been working to address this problem. One effort is to provide Pre-K education to students in low income areas in order to increase the number of students who are prepared to enter kindergarten. This requires funding and space necessary for the additional students, both of which are limited. The county, MCPS and state are working to increase funding. Eight of our elementary schools already offer full or half-day pre-K classes.

A group of concerned citizens from different parts of Eastern Montgomery County have formed a group called the East County Education Support Group (ECESG). This effort started two years ago when the Cannon Road School principal requested volunteers to assist teachers in grades K-3. Volunteers are also at Burnt Mills and Greencastle elementary schools (ES). The volunteers support the teacher as they determine best, often helping with students who need extra help with reading and basic math. The teachers who have used the volunteers are glad to have the help.

We would like to include more of our local schools in this volunteer effort and we are focusing on two efforts at this time. First, the American Association for the Advancement of Science (AAAS) has an existing volunteer program to support the K-12 Science, Technology Engineering, and Mathematics (STEM) teaching. If you have a STEM education and want to help out in this area, please contact AAAS. The AAAS program was introduced to school staff a year ago, and 130 of the 144 ESs across the county requested volunteers, but AAAS only had enough to support 38 schools. They are looking for more volunteers. Their program is described at https://www.aaas.org/senior-scientists-and-engineers/programs-dc.

The second volunteer effort is for non-STEM education. We have been working with MCPS to increase volunteers in this area and to create improved capabilities on the Montgomery County Volunteer Center web site for people to volunteer. We expect to be prepared to test the needed capabilities in September. We have principals at Burnt Mills, Page and Joann Leleck ES to test the pilot capability. The focus of the initial effort will be to provide help outside of the classroom. As this pilot develops and the school principals and teachers gain experience, we expect some volunteers will support the teachers directly – such as basic reading and math for those who need more individualized help.

Classroom help is not for everyone so volunteer efforts outside the classroom will always be available. MCPS will screen potential volunteers. Volunteers will need to go through a background check and take the online MCPS Recognizing and Reporting Child Abuse and Neglect Course.

If you are available to help in this area, we will provide more information in the fall, or you can let Dan Wilhelm know and he will keep in contact with you.

The Landing of Silver Spring: The Landing of Silver Spring is currently under construction at 13908 New Hampshire Avenue, on the north side of the Cambodian Buddhist Temple, and is projected to open in Oct/Nov 2018. It will have 79 assisted living apartments and 59 memory care apartments. At capacity, The Landing will have 194 residents, and a staff of approximately 100.

Randolph Plaza: Duffie Inc. recently opened its Randolph Plaza in Colesville, next to Colesville Center where the Giant is located. Duffie moved its headquarters into the office space so they could build the Hilton Hotel at their prior location in Hillandale. Hilton Home2Suites Hotel: The construction of this new hotel on Elton Road just off of New Hampshire Ave and the Beltway is progressing rapidly. This 100 room extended stay hotel is slated to open in Nov. 2018. They will have a wide variety of room layouts, many of them more spacious than a typical Hilton Hotel.

The building is designed to the LEED Platinum standard, the highest level. LEED stands for Leadership in Energy and Environmental Design, which is a certification program. While it costs more to build, the cost to operate and maintain the

building will be lower. One of the many benefits is the reduction in outside noise, which is important for this location since it overlooks the beltway.

White Oak Medical Center: With some 500 construction workers on site, the new hospital on Plum Orchard Dr behind the Target store is progressing rapidly. Construction has started on the parking facility and central utility plant and will start soon on the medical office building. The projected opening is July 2019. County Department of Health and Human Services (DHHS) Provides Assistance

The Montgomery County DHHS provides public health and human services that help address the needs of our community's most vulnerable children, adults and seniors. They have more than 120 programs and deliver services. Probably the best way to access that large number of services is by using the DHHS Care Coordinator, who assists individuals and families to access those services. A care coordinator is located in the East County Regional Services Center.

The east county care coordinator, Danielle Alvarado-Davis, will create an action plan for each client and assist them in connecting to the resources potentially available to them. She also provides individualized care coordination immediately for those families who are in emergency need. Danielle can also help with the application submission process for social services including Temporary Assistance for Needy Families, Supplemental Nutrition Assistance Program, Supplemental Security Income, Childcare Subsidies, and Emergency Assistance based on eligibility. Furthermore, she supports customers in applying for other State and Federal programs such as Social Security and Supplemental Security Insurance applications.


In a related update, Council Bill 14-18 Economic Development is a proposed bill that would require the DHHS to develop a Strategic Plan to Promote Prosperity and Increase Opportunity. The first area-specific plan must focus on Eastern Montgomery County and must be submitted by November 15, 2018. It would need to provide recommendations on how to increase the incomes of low-income households.

Federal Opportunity Zone

Two census tracts in Eastern Montgomery County have been nominated as an "opportunity zone" by Maryland for inclusion under the 2017 Tax Cuts and Jobs Act that was passed in December. Both Viva White Oak and the east side of New Hampshire Ave in Hillandale are covered (Hillandale Gateway is not included). If accepted by the U.S. Treasury Department, the Opportunity Zones would be eligible for tax breaks designed to help develop struggling neighborhoods. The \$1.5 billion "Opportunity Zone" program allows investors to take advantage of breaks on federal capital gains taxes by investing in small businesses and housing in lower-income communities.

This federal zone should not be confused with enterprise zones that have been established by the state for Burtonsville and Briggs Chaney. The EZ program provides real property and state income tax credits for businesses located in a Maryland enterprise zone in return for job creation and investments.

Wind Tunnel at the Federal Research Center

. Do you know that a one of a kind wind tunnel exists at White Oak.? The facility is being updated to Mach 18 (18 times the speed of sound). The speed of sound varies but at sea level it is about 760 miles per hour.


The former Naval Facility received two German wind tunnels after World War II. The tunnels helped initiate a fledgling U.S. supersonic research program.

The White Oak wind tunnel complex has gone through many changes since World War II including the addition of tunnels 3, 4, 6, 7 8 and 8A, which were all eventually replaced. In the 60s and 70s, the Navy felt there was a need to develop hypersonics to support the re-entry phase of their Submarine Launched Ballistic Missile Program. When a re-entry body, for example, is coming in from space, it is moving at 17,000 mph. So they developed Tunnel 9 to model these re-entry systems.

Tunnel 9 was originally planned for closure with the rest of the Navy Base as a result of the 1995 Base Realignment and Closure Act (BRAC). Through a coordinated effort between the Navy and the Air Force, the facility was saved and continued to operate as a remote site extension of the Arnold Engineering Development Complex (AEDC), TN.

The Hypervelocity Wind Tunnel 9 Facility provides aerodynamic simulation in critical altitude regimes associated with strategic offensive missile systems, advanced defensive interceptor systems, reentry vehicles, and hypersonic vehicle technologies. This facility utilizes a unique storage heater which provides supply pressures up to 1430 atmospheres and supply temperatures up to 1649 degrees celsius and sustains long-duration, constant-condition runs.
