3) Opening Comments: Chairman David Victor welcomed panel members and meeting participants. He explained the meeting was scheduled earlier in the day for the convenience of guest speakers from the Department of Energy (DOE) in Washington D.C. Chairman Victor introduced the agenda topics and guest speakers. Adding that Dr. Kim Petry and her team would help everyone understand the DOE's request for information (RFI) on consent-based siting for a federal consolidated interim spent fuel storage facility which is central to moving the spent fuel away from San Onofre. He also welcomed Michael (Mike) Frost, Mayor Pro Tem, City of Dana Point as the newly appointed alternate for Michael Villar, CEP member and Dana Point City Council member.

Doug Bauder provided a brief overview of work at the plant including the importance of the decommissioning principles: safety, stewardship, and engagement. The three major workstreams at the plant continue to be dismantling above-ground structures, safely managing spent fuel on site, and advocating for offsite storage and disposal. Doug urged CEP panel members and meeting

participants to check out the www.songscommunity.com website for decommissioning updates, time-lapse videos of dismantlement work, and nuclear facts. He also explained that his update would be kept brief so more time could be devoted to the DOE's presentation on the request for information, and that detailed decommissioning updates would be provided during future meetings.

- 4) DOE RFI on consent-based siting for federal consolidated interim storage facilities:** Dr. Kimberly Petry, presented an overview of the request for information on consent-based siting for federal consolidated interim storage. She explained that the DOE is requesting feedback from local communities, tribal nations, and organizations who want to learn more about the process and emphasized the DOE's commitment to remove barriers from participation to ensure all communities that want to be involved have the opportunity. Dr. Petry shared the department's desire to make progress on resolving the back end of the fuel cycle with a near term storage facility and a long-term repository for the spent nuclear fuel. She also discussed the growing importance of nuclear energy as part of the solution for decarbonization.
- 5) Local perspective:** Christian Abueg, policy advisor for Orange County Supervisor Lisa Bartlett, and Kristal Jabara, director of community affairs for San Diego Supervisor Jim Desmond, provided remarks on behalf of the ASFSN coalition. Both offered praise and support for the DOE's efforts and encouraged Dr. Petry to focus on the need for a long-term permanent repository and the prioritization for plants such as SONGS, when a site becomes available to ship the spent fuel to. The coalition also plans to provide a response to the DOE request for information.
- 6) National perspective:** John Kotek, offered a national perspective focusing on his past experience at the DOE, efforts to pursue consent-based siting and the challenges they faced, as well as current work on behalf of the industry to site facilities. He also emphasized the importance for keeping equally focused on the transportation efforts and coordination, as these also involve opportunities for states, tribal nations, and others to provide input and takes time.
- 7) International perspective:** Tom Isaacs, discussed the 2012 Blue Ribbon Commission report, what is happening now, and provided recommendations on ways people can work together based on his ongoing work in other countries. Tom reminded folks that consent-based siting was the number one recommendation from the Commission and an international best practice.
- 8) Chairman David Victor offered key takeaways summarized here:**
 - a) With the federal government's recent restart of consent-based siting, the CEP received an update from the DOE on the landscape for offsite storage of spent nuclear fuel. Representatives of the ASFSN coalition offered a local perspective, John Kotek of the NEI provided a national viewpoint and spent fuel expert Tom Isaacs offered international insights.
 - b) The DOE is responsible for disposition of the nation's spent nuclear fuel. DOE's Dr. Kim Petry

stated that federal interim storage allows for removal of spent fuel from reactor sites sooner than waiting for a deep geologic repository. DOE recently launched a process to hear from local communities, tribal nations, and organizations who want to learn about consent-based siting.

- c) Advocacy remains an important opportunity for communities neighboring San Onofre, and the coalition is well-positioned to serve as an organizing mechanism.
- d) The DOE's consent-based siting effort is an important listening process and comments are due by March 4. Later this year, it should help bring forward communities that want to learn more about what it means to be a host community for a spent fuel facility. That's progress.
- e) The renewed focus on the "back end of the fuel cycle" is owed in part to addressing climate change, and the need for clean power including but not limited to nuclear generation.
- f) Congressional action remains important, and one thing our local coalition can do is organize a list of key federal actions that would benefit us near SONGS and other plants. DOE has the authorization and funding for its initial work, but beyond a couple years will need more support.
- g) Other countries are ahead of the U.S. They are figuring out what consent means to their local communities. While there is no recipe book, we can learn from their efforts.
- h) The CEP should provide input to the DOE. The CEP leadership—David, Dan, and Martha—will draft and circulate comments to the full CEP membership for input.
