Shoupade Park Oakdale Road Smyrna, Georgia

Cobb County Register of Historic Places Justification Report

Physical Description

Shoupade Park is a passive park owned by Cobb County and consists of 2.35 acres. The park is located on the east side of Oakdale Road, approximately ¼ mile north of South Cobb Drive ¾ mile north of I-285. Located between two residential developments, the park sits on a ridge and contains earthworks built during the Civil War. From the ridge, views of the Atlanta skyline are visible.

The parcel contains two examples of a unique type of Civil War redoubt, known as Shoupades, built in Cobb County by the Confederate Army during the summer of 1864. An artillery redan is located between the two Shoupades. The Shoupades and artillery redan are fenced by a black chain-link fence. One Shoupade and the artillery redan are surrounded by trees and vegetation. The second Shoupade is located at the top of the ridge in an open area. The resources run in a somewhat linear manner from west to east, with the second Shoupade located slightly to the north. The earthworks are in good condition.

Parking spaces are provided along Oakdale Road and a pedestrian access gate grants entrance to park visitors. A walking trail extends from the access gate, up the ridge and along the southern property line. Interpretive signage is placed at intervals along the walking trail detailing the significance of the Shoupades and the site.

The property was preserved as part of the development of the two adjacent residential subdivisions in 2007. The property was transferred to Cobb County in 2010.

Historic Significance

The Shoupades and artillery redan located at Shoupade Park were part of the larger Chattahoochee River Line. The Chattahoochee River Line was a line of fortifications designed by Francis A. Shoup of the Confederate Army, General Joseph E. Johnston's Chief of Artillery, to block Union General William T. Sherman from crossing the Chattahoochee River.

In 2011, the Archaeology Inventory and GIS Analysis for the Chattahoochee River Line Battlefield was completed with the assistance of a grant from the National Park Service American Battlefield Protection Program. The study describes the Chattahoochee River Line as "a unique system of earthworks built largely by impressed slave labor and occupied by the Confederate Army of Tennessee between July 5 and 9, 1864".

The Shoupades were diamond-shaped and roughly ten to twelve feet high. Parapets were constructed at the top of each Shoupade, which added to the height. Each fort could hold about

eighty men. The fortifications were placed at various intervals and were connected by a stockade of vertical logs. A redan for two artillery pieces was placed between two Shoupades. Sherman decided to avoid the line of fortifications and eventually crossed the Chattahoochee River north of the River Line.

Approximately 36 of these Shoupades were constructed as part of the approximate seven-mile long Chattahoochee River Line. Today, only 9 are known to remain due to development and suburbanization. The Shoupades and artillery redan at Shoupade Park are significant examples of these unique fortifications. Together with the extant redan, the earthworks at Shoupade Park are also an excellent example of how the Chattahoochee River Line was designed and built.



Shoupade Park in the 4700 block of Oakdale Road. The two Shoupades and an artillery redan were preserved as part of a housing development by Pulte Homes in 2007. In 2010, this property was acquired by Cobb County and it encompasses 2.35-acres between neighboring housing developments. The park consists of a small parking lot, walking trail, two Confederate Shoupades, an artillery redan and interpretive signage erected by the Georgia Battlefields Association.

The design of the River Line is also significant in the history of Civil War engineering. The River Line was composed of a series of connected infantry trench lines, artillery redans and redoubts. During the Civil War, redoubts consisted of any enclosed polygon and were often simply an enclosed square. Redoubts were generally designed with walls made from parapets, a ditch on the outside, and some form of breastwork for protecting gunners or riflemen. The Shoupades of the River Line were a unique type of infantry redoubt, as it is an enclosed polygon. They were designed with a diamond, or "arrowhead" shape, with salients that faced towards the enemy, and shorter rear walls enclosed in the rear. Shoupades were built only on the Chattahoochee

River Line Battlefield and represent an innovative defensive design. The Shoupade redoubts were laid out on high ground in a sawtooth pattern, dispersed with V shaped artillery redans containing two guns each. This design allowed for a system of alternating Shoupades and artillery redans to protect each other with overlapping fields of fire. This system was sufficiently formidable to convince Sherman and his officers of the futility of attacking the River Line.
