### VII. SPLOST UPDATES

Barbara Savage

- Lions Park Concession Construction is complete and currently working on the obtaining CO and working on the contract closeout.
- Hyde Farm Historic Registry The farm meets the criteria to be listed on the National Register of Historic Places.
- Noonday Park Restroom Restoration The back bathrooms are being renovated.
- Old Clarkdale CMU block for the buildings are done; Most concrete sidewalks have been poured; trying to tie in the sewer line to an old line and are trying to get Cobb Water to help us get the water flowing up hill to the building. Trusses for building were ordered but are currently sitting in Canada right now. We are still 4-5 weeks out before we can get the trusses delivered. PARKS Land Unit has been planting the trees at the property. Hope to have this project completed by end of April.
- Nesbitt Union Chapel Footings have been dug and poured, the steel for the ghost framing is being fabricated in the shop, steel to start coming in next week; Project completion is set for Mid-March.
- Terrell Mill Park Synthetic Turf Fields Most of fencing has been removed, dugouts have been removed and will be reinstalled, light poles have been moved, grading operations have been ongoing this week, installing curbs and turf nailers on field 2, moving some scoreboards, and will continue to form and pour curbs for the turf.
- Stout Park Buildout of the Master Plan has been cleared for permitting; will be issuing a sealed bid contract once permitting process is complete.
- Mable House Art Center Detention Pond PARKS Land Unit has been doing this
  work. We have sod left to add and then the one by Floyd Road will be completed. In
  the next couple of weeks, the Land Unit will start the other detention pond near the
  building.
- Osborne Recreation Center Currently in the due diligence phase of the acquisition process; there will be a public input on this project after purchase; have issued the RFP for the designer on Jan. 25 and had 19 firms represented at that meeting. Proposals are due this Thursday. The RFP for CM at Risk will be advertised on Friday and are due on March 10. Hope to have both Designer and CM at Risk under contract by this Summer and start construction Summer 2023.

#### • SPLOST Projects

Miller Arena Bleachers – were approved at the January 25 meeting. The bleachers are in procurement and are anticipating installation after the circus, but before the fair. Fair Oaks Storm Sewer Rehabilitation – Bid documents went to Purchasing last week and will start advertising February 25 and will we accept bids on March 24. Hope to start project mid-Summer

Fullers Streambank Restoration – Engineer now creating drawings to enable us to repermit the Fullers side so that we can go forward with the Flex-a-mat project.

Mable House Complex Signage – Approved by BOC on January 25 and procurement documents are being prepared. We expect installation late Spring on the signage.

- East Cobb Streambank Permitting for the site has been completed for East Cobb. We are waiting on the Fullers Park permitting to be approved.
- Gymnastic Center Drywall and paint have been completed, floors have been stripped and buffed, carpet tiles have been received, flooring work has been completed, and the equipment replacement list is at hand but are waiting on the Claims Adjuster to review and finalize.
- Cobblestone Golf Course Interior egress is 95% completed, carpet and millwork has been completed, granite countertops have been measured and ordered, and there are a few punch list items remaining. Exterior egress issues are in progress. Completion is set for one to two weeks from now.
- Miller Event Center The standby generator has been installed and completed. We are awaiting on the final inspection from the Fire Marshal and hope to have that done by the end of the week.
- Aquatic Centers Boilers Mtn. View boiler is completed, the contractors have moved onto the South Cobb Aquatic Center and once that is completed, they will go to the Central Aquatic Center to install the boiler from Mountain View.
