COBB COUNTY HOUSING ASSISTANCE HELP

For persons needing non-COVID-19 related housing assistance.

The Cobb County CDBG Program Office administers the following Federal programs in partnership with local nonprofit organizations that may offer rental/mortgage assistance, if funding is available:

HOME Investment Partnerships (HOME) Program

Rental Assistance

The primary purpose of the HOME Program is to expand affordable housing options for persons of low and moderate-income. A HOME eligible activity, Tenant Based Rental Assistance (TBRA), provides monthly rental assistance, security & utility deposits for clients with income at or below 80% AMI.

Emergency Solutions Grant (ESG) Program

Rental Assistance/Emergency Shelter

The primary purpose of the ESG Program is to assist people in quickly regaining stability in permanent housing after experiencing a housing crisis and/or homelessness. Homelessness prevention activities serve clients who are at-risk of becoming homeless and with incomes at or below 30% AMI.

Emergency Food & Shelter Program (EFSP)

Mortgage/Rental/Utility Assistance

EFSP funds are used by Local Recipient Organizations (LRO) for mass shelter, mass feeding, food distribution through food pantries and food banks, one-month utility payments to prevent service cut-off, and one-month rent/mortgage assistance to prevent evictions or assist people leaving shelters to establish stable living conditions.

Community Services Block Grant (CSBG) Program

Rental Assistance

The primary purpose of the CSBG Program is to address the causes of poverty by implementing programs and services that empower low-income families and individuals, revitalize low-income communities, and improve the economic self-sufficiency of low-income individuals. CSBG beneficiaries must be at or below 125% of the Federal Poverty Guidelines.

HOW DO I RECEIVE ASSISTANCE?

Contact one of the nonprofit organizations providing housing assistance to inquire. Please note that some Organizations only take intake on certain days or may no longer have funding available to provide assistance.
