• SPLOST Budget Update:

2011 Projects – 98% Completed; 2% Future Projects.

2016 Projects – 80% Completed; 1% Design; 5% Under Construction; 14% Future Project (Future Projects: Hyde and Miller) All projects are underway currently, but the 15% percentage is due to projects that have not had the money allocated yet. 2022 Projects – 88% Future; <1% Completed; >2% Construction Underway; <1% Design/Engineering (Future Projects: Aquatic Centers, Technology Improvements, Ebenezer Downs, and Noonday Park Restroom)

COBB COUNTY RECREATION BOARD MINUTES

May 9, 2023

- Old Clarkdale Community Center Contractor is under contract and project will take approximately 8 months. Silt fencing has been installed; Meeting on Friday with the Fire Marshall.
- Stout Park/Stana House —Decel lanes and widening the entrance on Brownsville Rd have been completed; signals for the crossing have been ordered; fire line has been installed; Interior bids will be held on Thursday; Stairs have been installed and awaiting Fire Marshall approval; Exterior of the Barn is in process, but working through quality and timing issues with the contractor.
- Hyde Farm National Registry received comments back from them to update and will be resubmitted.
- Miller Arena Sound Booth is in disrepair and will be demolished.
- Sewell Pool We have demo'd the surface of the pool and applied Diamond Bright; curing done on Friday; pool will open on 5/27.
- Furr Park PO is in process to pave the driveway.
- Hurt Road Park Project will be to add more parking for the basketball area.
- Lost Mountain Park Project will consist of dredging the lake, cutting trees off the dam to repair the leaking dam.
- Rhyne Park Streambank FlexiMat has been installed; fixing pipes and erosion.
- Florence Road Trailhead Paving bids out on 5/12; Will review bid in June.
- PARKS Signage Will be installing signs at 16 parks to display the park rules; will take approximately a month to complete.
- Aquatics Dehumidification systems installation approved today; West Cobb
 Aquatics will be the first facility to be replaced, then South Cobb, and finally
 Mountain View.
- Big Shanty Park Project will be to add additional parking and pickleball courts (later); project is currently in the design phase.
- Noonday Park Restroom Restoration Designer on board; will install 8 restroom pods in between fields 4 and 5; this will be a 6-month project.
- Wild Horse Creek Lake Bidding out removal of silt currently; 2-3 weeks to complete; Anticipated completion later in Summer.

VII. DEPARTMENT UPDATES

Derrell Walker

- Operations Routine maintenance is happening in all zones currently and is picking up.
- Events Currently prepping for the concert series by adding sod to the lawns; built pads to sit on.
- Working on fence repairs across the parks.
- Adding more slate rock to our walking trails for safer travels for citizens.
- This past weekend, we had a GRPA Track Meet; Cobb County finished well in the series.

Mario Henson

- Aquatics Sewell Pool and Seven Springs open Memorial Day weekend.
- We have a new Aquatic program for special needs.
- All Aquatic facilities now offering swim lessons since we are fully staffed.
- Arts International Festival will be August 26th at Miller Park.

- Mable House Barnes Amphitheatre Concert season is in full swing.
- Anderson Theatre nominated and won a Telly Award.
- Miller Park The circus will be in town May 20-May 29th.
- Natural Resources Just hosted Fishing with TRS at Lost Mountain Park.
- Tennis May is National Tennis Month; National Tournament will be at Harrison Tennis Center on May 20th.
- Recreation Centers All centers are prepping for Summer Camps; all centers are fully staffed and ready to go.
- Terrell Mill All Star Invitational Baseball will be held Memorial Day weekend.

Jordan Wood

- Bob Callen Bridge Renovations Project delayed due to engineering issues.
- Al Bishop Parking Expansion Project is to expand the available overflow parking area for the fair by 4 acres or 241 additional parking spots; Gaskins+Lecraw are the designers; Plans awaiting Community Development approval; asked the Fair Board to help with funding since the pricing came back higher than anticipated, but it was declined; will have to go out to bid for this project.
- Schmidt Family Park Improvements Project will renovate the existing home; will then be offered as a living space for Cobb County PD; total interior gut and remodel; PARKS Construction Unit will mostly complete the interior gut of the house; will be installing underground power as well.
- South Cobb Aquatic Center Play Structure Replacement PO issued for DC Pools to demo old play structure and replace with a new Mushroom water feature.
- Pool Gutter Replacement Locations: Mountain View, South Cobb, and West Cobb; Sole source product so we can purchase pre-dimensioned specifically for each location due to safety concerns.
- Aquatic Center Locker Room Flooring and Partitions Currently crafting scope of work and will three-bid this project.
- Disc Golf at Hubert Park Project will potentially be a 9-hole par 3 layout that will be appropriate for beginners through advanced golfers; currently pricing and purchasing equipment.
- Veterans Memorial Meeting with County Leadership and Veterans Memorial Foundation Board to discuss current cost estimation; will be meeting with Carroll Daniel (Cost Estimator) to discuss VE options and revised pricing.

Michael Brantley

- Mario has done a great job acquiring grants for the department.
- Update on incident at Nickajack Park last week.
- Holiday Light Show Drive Thru could be held at Jim R. Miller Park from Thanksgiving through January 1st; the Event Center hopes to have an ice-skating rink inside, slide, Santa, cookies, and smores. Cost will be around \$45-55/car. Currently negotiating with Shadrack Productions.
