- (2) **Project:**

South Cobb Drive (SR 280) is a four-lane undivided roadway that currently has a high crash rate including vehicles running off the road and breaching the security barrier of Dobbins ARB. This project will provide safety and operational improvements on South Cobb Drive (SR 280) from Atlanta Road to Cobb Parkway (SR 3/US 41). It will enhance public safety for motorist and pedestrians travelling eastbound and westbound on South Cobb Drive adjacent to Dobbins ARB.

- (3) **Disadvantaged Business Enterprise:**

CCDOT has adopted a 15% Disadvantaged Business Enterprise (DBE) participation goal assigned to this scope of services. This goal is not to be considered as a fixed quota, set aside or preference. CCDOT will monitor and assess each consultant services submittals for their DBE participation and/or good faith effort in promoting equity and opportunity in accordance with the state of Georgia, Department of Transportation DBE Program Plan.
