The polls will be open from 7:00 a.m. to 7:00 p.m., and the election will be held at the following election precinct.

Qualifying for candidates will open on Monday, March 4, 2024, and close on Wednesday, March 6, 2024, 2024. The hours for qualifying shall be between 8:30 a.m. and 4:30 p.m. each day, but will close for a one (1) hour lunch break from 12:00 noon until 1:00 p.m. Qualifying shall be held in the Training Room at the Kennesaw City Hall, 2529 J.O. Stephenson Ave., Kennesaw, GA 30144. Each candidate must meet the qualifications for office as prescribed by State Law and Municipal Code. Each candidate or his or her designee shall file a Notice of Candidacy and Affidavit, such form is available at <a href="www.sos.ga.gov">www.sos.ga.gov</a> and will also be provided at the qualifying location. The qualifying fee shall be payable by cash, check, or money order made out to the City of Kennesaw in the following amounts of \$360.00.

**Residents of Kennesaw** may register to vote through the close of business Monday, April 22, 2024. Those who are qualified to register to vote for this election may do so by clicking "Register to Vote" at <a href="www.sos.ga.gov/elections">www.sos.ga.gov/elections</a> or by appearing in person at any of the designated places for registering Cobb County residents. If you have moved into, out of, or within the city limits of Kennesaw and have not notified the Cobb Board of Elections and Registration, please do so no later than April 22, 2024.

**Advance Voting** will be available <u>between April 29 and May 17.</u> The Advanced in Person schedule is available on the <u>www.CobbElections.org</u> website.

**Voters may apply to Vote-by-Mail** by submitting an application to the Cobb County Elections Office between March 4 and May 10. Applications can be submitted by mail to P.O. Box 649, Marietta, GA 30061-0649, by fax to 770/528-2458, or by scanning and emailing to absentee@cobbcounty.org

Applications are available at <a href="www.CobbElections.org">www.sos.ga.gov</a>. Mail-in ballots must be received by 7:00 p.m. Tuesday, May 21, 2024, either through the mail or personally delivered.
