- A: Financial information may be included within a separate envelope inside the hard copy proposal response package. Financial information may also be included as a password protected file on the flash drive but the password must be contained somewhere within the hard copy proposal response package; it cannot be sent separately. As long as there is a hard copy of the financials included in the proposal response, an electronic copy is not required. Financial information is only shared with the Finance Department (who will score for Financial Stability). Financial statements are considered trade secrets and are not subject to open records requests under Georgia law as long as the Contractor submits and attaches to such records an affidavit affirmatively declaring that specific information in the records constitutes trade secrets pursuant to Article 27 of Chapter 1 of Title 10, and the Parties shall follow the requirements of O.C.G.A. § 50-18-72(a)(34) related thereto.

MEETING MINUTES:

(1) Introductions and Agenda

The meeting was opened and Cobb County staff (present or online) introduced themselves. Attendees online via Microsoft Teams were asked to provide their name, company/organization, and email in the Teams chat. In person attendees provided this information on a sign-in sheet. The attached attendee list provides the full list of inperson and Teams attendees.

(2) Project Overview:

Allatoona Creek Greenway Trail is one of the eight priority trails identified in the Cobb County Greenways and Trails Masterplan adopted in 2018. The plan supports a safe, interconnected network of greenways and trails in Cobb County. Implementation of the priority trails will provide a broader trail network that will improve regional connectivity and increase access to existing trails, parks, schools, and historic/cultural resources.

A map of the proposed trail was presented along with the description of the project limits, key trail connections, and major roadway crossings.

Allatoona Creek Greenway Trail will be approximately 5 to 6 miles, including potential spur trails. Approximately 60% of the trail is through or adjacent to public lands, including US Army corps property, as well as Cobb Parks and School District. It was noted that the trail project is supported by the group Friends of Price Park. Kemp Park, also adjacent to the trail, will undergo a master planning effort.



Background: Cobb County Greenways and Trails Master Plan


- Adopted 2018

Background: Allatoona Creek Greenway Trail

- Study area Allatoona Creek stream corridor
- North end: kayak launch in Allatoona Creek Park @ County Line Road
- South End: Due West Road
- Spur Trail west to West Cobb Regional Library
- Linkages: Allatoona Creek Park, Price Park, Kemp Park, West Cobb Library, Harrison High School and/or Lost Mountain Middle School
- Key crossings:
 - Mars Hill Road
 - Stilesboro Road
 - Hadaway Road
 - · Burnt Hickory Road
 - Due West Road





Allatoona Creek Greenway Trail

- Approximately 5 to 6 miles, including potential spur trails
