(1) This is the Pre-Proposal Conference for Cobb County Department of Transportation (CCDOT) projects – Cumberland Core Loop – Segment D, Cobb County Project No. B2434, GDOT P.I. No. 0019780 and Cumberland Core Loop – Segment E, Cobb County Project No. B2433, GDOT P.I. No. 0019618. Request for Qualifications (RFQ) will be received until 12:00 noon on March 28, 2024, at Cobb County Procurement Services Department, 122 Waddell Street, Marietta, Georgia 30060. Proposal will be opened by the Procurement Services Department at 2:00 p.m. on March 28, 2024, at the Cobb County Procurement Services Department.

(2) Project:

Cumberland Core Loop - Segment D begins at the terminus of Segment C utilizing the existing pedestrian bridge over I-285 and extends north along Heritage Court to Windy Ridge Parkway. The aim is to provide a shared-use path and autonomous circulator facility on the existing pedestrian bridge. There will be modifications of the bridge as needed including architectural lighting on the bridge exterior. Continuing north on Heritage Court through the Battery, the autonomous circulator will use the existing roadway network. A shared-use path will be constructed on the west side at feasible locations. The entire segment will include landscaping, lighting, and wayfinding signage.

Cumberland Core Loop - Segment E begins at the terminus of Segment D and extends along Windy Ridge Parkway from Heritage Court to Interstate North Parkway (see location map, page 19). The aim is to provide a shared-use path and autonomous circulator facility along Windy Ridge Parkway. The selected design firm must evaluate options of the autonomous circulator traveling within the existing roadway network and separate

multi-model infrastructure. A shared-use path must be constructed regardless of the autonomous circulator travel option. The segment will include landscaping, lighting, and wayfinding signage.

(3) Disadvantaged Business Enterprise:

CCDOT has adopted a 15% Disadvantaged Business Enterprise (DBE) participation goal assigned to this scope of services. This goal is not to be considered as a fixed quota, set aside or preference. CCDOT will monitor and assess each consultant services submittals for their DBE participation and/or good faith effort in promoting equity and opportunity in accordance with the state of Georgia, Department of Transportation DBE Program Plan.

(4) Special Items to Note:

The project consists of funding by Federal and local sources. Accordingly, the successful firm will be required to comply with all applicable Federal, State, and County rules and regulations. The funding sources require this project to conform to the Georgia Department of Transportation's (GDOT) Plan Development Review Process.

All engineering services shall be in accordance with all applicable guidelines of the American Association of State Highway and Transportation Officials, GDOT Standard Specifications for the Construction of Transportation Systems, Project Schedules, Plan Development Review Process, and Plan Presentation Guidelines, CCDOT Pre-Construction Process and Procedures Manual, and all other applicable CCDOT guidelines.

CCDOT anticipates two (2) Multi-Phase, Project Specific contracts to be awarded to one (1) firm. The firm shall ensure that all documents in the Preliminary Engineering phase can be tracked for each PI number, including cost estimates, quantities, invoicing, etc. CCDOT anticipates that the Contract Type may be Lump Sum, Cost Plus Fixed Fee, Cost per Unit of Work or Specific Rate of Compensation. As a Project Specific contract, it is CCDOT's intention that the Agreement will remain in effect until construction completion.
