Purpose for Meeting

Legal requirement as defined in House Bill 930:

- Written notice to Mayor or chief elected official in each qualified municipality
- Establishment of a meeting including the County and each municipality to discuss possible transit projects for inclusion in the referendum
- Meeting to be held at least 60 days prior to any issuance of call for referendum (municipalities to be notified 10+ days prior to meeting)

Purpose for Meeting

Overall process and project selection guided by the Atlanta Regional Transit Plan (ARTP), which originated from the CobbForward Transportation and Transit Plan
















Existing System

- Current System:
 - Limited coverage of the county, targeted to areas of greatest need
 - Basic modes currently included
 - Some coverage provided for vulnerable populations
 - Standard frequency of service provided for existing modes





25+% of Cobb population over the age of 55 (and growing)



Countywide microtransit and expansive paratransit can support those who are unable to drive or uncomfortable driving



One-third of population under the age of 25



Younger generations are showing less desire to drive vehicles and an interest in having multimodal options available



Cobb County is adding more countywide and regional destinations



High-capacity transit, transit centers, and other supporting services can provide effective and efficient connections

73 Miles of Bus Rapid Transit (Seven Lines)


34 Miles of Arterial Rapid Transit (Three Lines)

Transit Supportive Projects

> \$1B (YOE) Over the Life of the Plan

> \$500M to Transit Access Projects

Trails, Bridges, Bike/Ped Improvements

\$500M to Transit Operations Projects

 Capacity Improvements, New Connections, Grade Separations, Intersection, and Roadway Operational Enhancements

Funding Distributed to Cities Based on Population Proportions


\$600M (\$2024) in Identified Eligible Projects from the CobbForward Plan (other projects can be considered if meeting criteria)





Transit Project Phasing: 2025-2030 (Five Years)



Transit Project Phasing: 2025-2035 (Ten Years)


- 4 Bus Rapid Transit Routes

- 4 New Local Routes
- 2 Transit Centers





Summary

- > 100% transit coverage to access jobs in Cobb County
- > 100% coverage of vulnerable populations (disabled, poverty, zero-vehicle and 65+)
- Reduce demand for parking in business districts
- Provides alternative to traffic congestion
- Meeting the needs of a growing Cobb County
- Provides opportunity to leverage federal infrastructure investments
- MSPLOST would transfer transit funding from property tax (residents) to sales tax (residents and visitors)





What the Cities Can Expect

- In the immediate future
 - Coordination on transit supportive projects of interest, for each city
 - Coordination on project delivery methods and preferences to consider
- ➤ If/After MSPLOST passes
 - Future coordination with planning efforts related to larger capital projects (station area, TOD, etc.)
 - Collaborative delivery of transit supportive projects and ways of communicating project progress

FAQs

> How were the high-capacity transit routes identified?

All high-capacity transit routes (BRT, ART) have been developed to match areas of existing and future high transit propensity, existing and future travel patterns, and stakeholder feedback.

>Has it been determined the best method for project delivery of the transit supportive projects?

Cobb County staff is currently determining the best method for project delivery and a decision will be made in conjunction with the cities' input.

> How much funding is projected to come from non-residents?

\$11B is estimated to be collected from MSPLOST, where over \$2B of this projected total is from non-residents (visitors, tourists, and non-Cobb County commuters).

>How much funding is projected to come from federal funding?

The MSPLOST financial projections estimate over \$2B of new federal grants to help fund expanded transit operations and capital costs.
