

### News and Views from the Cobb Probate Court



### A MESSAGE FROM THE CHIEF

The Legislative Session is back in full swing. While I try to stay up on the happenings down at the Gold Dome, I try to stay out of the way. There are some matters impacting our class of court that are of interest. I am not attempting to persuade, but only to inform here, so please don't shoot the messenger if you have feelings.



>> HB 180 attempts to make qualification for Article VI judges match the requirements to serve as an Article VI Probate Judge. Currently, all probate judges have to sign an affidavit as part of qualifying as a candidate for probate judge. The affidavit sets the requirements for all probate judges across the state - minimum age of 25, residency requirement, etc. There is no specific affidavit when the person is seeking election to an Article VI Court. In those cases, the candidate must be a licensed attorney for the required period of time, attained the age of 30, etc. but can swear to the less restrictive credentials at qualifying. HB 180 bill simply attempts to align the requirements with the qualification paperwork.



>> HB 36 is a bill seeking to expand the list of professionals authorized to perform evaluations in adult guardianship and/or conservatorship cases. The unfortunate truth is that there are counties without qualified evaluators available within or surrounding the county. Some courts are known to require petitioners to identify an evaluator to perform the independent evaluation of a proposed ward. Here in Cobb County, with a population of nearly 800,000 people, we only have 4 court appointed evaluators. So this is an effort to reflect the current state of medical care in Georgia and allow for additional professionals to serve.

There is also legislation proposed that seeks to make all Georgia Probate and Magistrate judges nonpartisan. This is different than previously passed local legislation around many metro counties (including Cobb) and beyond that made those local positions nonpartisan (over time since the mid-1980s). This is an effort to make all judges non-partisan and was mentioned by Justice Boggs in his state of the Judiciary address to the General Assembly. As always, the legislative session is a time of constant change. We will try to update you with anything that makes it through and impacts our court.
