

# Cobb County Toilet Retrofit Rebate Program

By submittal hereof, customer acknowledges that the rebate shall be paid by a one-time credit to be applied to customer's Cobb County Water System bill, and that the credit shall be as follows: **\$100.00 for WaterSense Labeled Ultra High Efficiency toilets, 1.1gpf or less, maximum of 3.** Customer further acknowledges that the rebate program is subject to available funds and may be cancelled at any time without notice. Credit is available only for qualifying toilets as determined by the Cobb County Water System, check website before submitting to ensure current eligibility.

Rebate eligibility checklist (you must check **all** to be eligible):

- ☐ My home was built before 1993.
- ☐ I am a customer of the Cobb County Water System.
- ☐ I do not pay my water bill through a HOA or condo association (my bill comes directly from CCWS).
- ☐ I am installing a WaterSense Labeled Ultra High Efficiency toilet, **1.1 Gallons Per Flush** (gpf) or less.

Important Information:

- The toilet rebate program is based on funding and may be discontinued at any time. Please feel free to contact us before submitting your application to find out if funding is still available.
- We will rebate up to a maximum of 3 toilets per household at \$100 per toilet.
- To receive a rebate, you must send in a completed, signed application along with the itemized purchase receipt for the toilet. Please keep a copy of each for your records.
- Some dual-flush toilets are not eligible for the rebate. For dual-flush toilet eligibility, please contact us prior to purchase.
- If you are installing a new toilet in a rental home that you own, where the bill is in a tenant's name, please be aware that the **credit will be applied to the water bill at the installation address**. We cannot transfer a credit to a different account or give a check for the credit.
