Updates to 2025 CDBG Program Recommendations:

The final funding recommendation for Cobb County – Fair Housing Activities the Public Services category has been reduced by \$5,000.00, for a revised allocation of \$15,000.00. This adjustment was made to correct the Public Services subtotal and ensure that the overall CDBG program allocation aligns with the approved total allocaation of \$3,420,467.00.

Updates to 2025 HOME Program Recommendations:

The final funding recommendation for Cole Street Development Corporation's Acquisition and Rehabilitation – Rental project has been increased by \$0.10, for a revised total of \$295,311.06. This minor adjustment was made to correct a rounding discrepancy in the previous calculation.
